Santa Clara Stadium Authority Financial Status Report

- Covers the first quarter of the 2016-17 fiscal year (April 1, 2016 to June 30, 2016) with comparative data from the 2015-16 fiscal year
- Reports available on the Finance Department's webpage and the new Stadium Authority webpage



Non-NFL Events

- Eight ticketed non-NFL events were held during the first quarter of the fiscal year
- A total of 351,837 tickets were sold
- In addition, there were 31 smaller special events with 13,709 attendees
- The \$4 per ticket non-NFL ticket surcharge generated \$1.41 million (one-half for stadium operations and one-half for Stadium Authority discretionary fund)





- The expenses from the discretionary fund have been NFL public safety costs above the public safety cost threshold, a total of \$1.41 million since the stadium opened
- The balance in the discretionary fund is currently \$1.25 million




Non-NFL Events - Parking



- A total of 34,376 cars were parked in offsite lots generating \$175 thousand in offsite parking fees
- A total of 9,562 cars were parked on the golf course resulting in \$47,810 thousand in parking fees



Non-NFL Events-Public Safety Costs



- A total of \$1.66 million of public safety services were provided for non-NFL events
- \$175 thousand of the public safety costs were covered by the parking fees and the remaining \$1.48 million were invoiced to ManagementCo.
- \$925 thousand of the public safety cost reimbursements were outstanding as of 8/12/16



Outstanding Debt

• Total outstanding debt as of 6/30/16 was \$447.45 million (down from the peak of \$675.8 million in 2014-15)



CIP Budget

- The Stadium Authority appropriated \$3.00 million in the 2015-16 fiscal year and \$300 thousand in the 2014-15 fiscal year for stadium CIP costs
- No funds have been expended through 6/30/16 (the \$3.3 million of prior year appropriation has been carried forward and \$1.7 million is projected to be expended in 2016-17 on seat covers for the upper bowl, LED lighting upgrade, kitchen equipment, water treatment, fire alarm system, and other improvements)



2015-16 General Fund Benefits

- Revenues of \$4.06 million exceeded expenditures of \$1.72 million by \$2.34 million
 - The City received \$1.05 million of public safety cost reimbursement
 and \$81 thousand of administrative costs reimbursement
 - \$2.93 million performance rent was received
- In addition, direct Stadium sales tax collections of \$186 thousand for the quarter and \$765 thousand over the last four quarters were received by the General Fund
