I agree that the area between Lawrence and Scott, and El Camino and Pruneridge, would constitute an area that is comprised of high-density (historical 2-plex, 4-plex, townhomes, and apartment complexes) as well as single-family homes, and of people who would identify themselves as living "near Central Park". There is also a good demographic mix (racial, children/elderly, and income bracket) in this area due to a combination of renters and home-owners.

**Are there any draft maps you do not support? Explain why.**

Map #5 cuts the "Central Park" neighborhood in two. It really doesn't make sense to declare White Drive, which is not even a major street, as the eastern boundary and it \*also\* doesn't make sense to exclude residents immediately east of Central Park from a district that may make decisions that would have an impact on them.

I believe that proposed Maps #1-3 create a district between State Road 82 (El Camino) and Highway 237 that is disproportionate from a demographic perspective, as well as from a square mile perspective. It would contain an overly large percentage of Santa Clara's businesses and industry. Any of these proposed districts (Map #1-District 2, Map #2 and Map #3-Districts 1+2) would be faced with choices around infrastructure, new development/construction, and transportation (CalTrain, BART extensions) that are not relatable to residents in the other districts.

### **Do you prefer any of the draft maps? Explain why.**

This districting process is too rushed and is not allowing enough time for thorough analysis or community input. However, I realize that this is a court order and we do not have much choice.

It looks like we need an interim solution for November 2018 to satisfy the ridiculous time frame demanded by the courts. Since the court system likely wants to see "single-member districts", we are stuck with 6 or 7 districts.

For November 2018, as an interim solution, I would choose map #4 (6-district plan)

With map #4, in Nov 2018, we would elect a councilmember from two of the districts only.

Finally, drawing 6 districts alone will not solve the problem of minority representation on our city council. If multiple minority candidates run for office in a district, they could easily split the vote among each other, and the incumbent would still win.

The typical solution for this problem would be run-off elections. However, we all know that run-off elections are expensive and turnout is typically low.

These problems can be solved by requiring Instant Runoff Voting, otherwise known as IRV, in year 2020. IRV is a form of Ranked Choice Voting and is used in San Francisco, Oakland, San Leandro, and many other cities across the country. The state of Maine even uses it for its primaries and its Congressional elections.

The court agreement language should clearly state that IRV should be used for all elected offices as soon as the election equipment is available. (County election equipment will likely be able to support IRV by the year 2020.)

I would also support a plan for 2020 that uses no districts and Ranked Choice Voting for all elected offices to ensure minority representation.

### **Are there any draft maps you do not support? Explain why.**

I do not support either of the 7-district proposals. They split well-defined neighborhoods, including my own. These 7-district maps are obviously drawn by someone who has never set foot in Santa Clara. Also, looking at the numbers on the court website, the 7-district plans do no better at defining the majority Asian-American district that will be expected by the court. Map #4 (6-district plan) already creates the required majority 51% Asian-American CVAP district. These proposed 7 district plans do no better than that.

### **If the Court adopts a seven district map, the Mayor would no longer be elected by the City voters at-large. Do you support this change? Explain why.**

I believe our city should continue to have an elected mayor. The mayor needs to be a single elected leader that is accountable for his or her actions. The mayor needs to be able to effectively lead city council meetings and represent our city in external affairs. The mayor should have to \*earn\* this position in an election. For example North Santa Clara is kept mostly in whole in District 1. District 2 represents the more sparsely populated areas but has two coherent population areas (North of 101 and south of the railroads). I'd imagine that after City Place is built some reshuffling will happen but that is a future concern.

District's 3 - 6 all represent the rough makeup of those communities - Homestead/Bowers/EI

Camino/Wolfe/Saratoga are major roadways and reflect the rough boundaries.

Additionally, I believe Map #4 (Draft Plan 1) is the only map that will pass both adhere to the CVRA as well as the court's review given the population distribution.

Yes, being a lifetime resident I have seen many issues split the city in two. I personally believe having the city split along the el Camino with 3 council seats each and the mayor elected at large is the best option for Santa Clarans. I think ranked choice was too difficult for most people to understand and cause measure A to fail.

I vastly prefer the two- and three- district maps proposed by the committee, but any of the drafts submitted by the city are vastly preferable to the plaintiff's proposed maps, which seem to me to be tone-deaf in terms of creating districts that have no apparent commonality.

yes - both of the plaintiff's maps have an artificially constructed district 2 that somehow places my neighborhood (Lake Santa Clara - in the 49ers backyard area) in a district along with areas far south of 101 that share virtually none of the challenges we face in terms of traffic, airport noise, construction, etc. I see no commonality between my neighborhood and the area around Monroe street, yet somehow the plaintiffs' proposal places us in the same district - essentially totally diluting the influence of those of us in the small slice of District 2 north of 101.

I do not. This presages a weak mayor system, in which the power is concentrated in council members elected by a very small section of the city.
