Matters for Council Action: None

1. Welcome and Introductions

Meeting called to order at 4:06 p.m. Red Peak began by reviewing the agenda and the creative review process of brand identity.

2. Review strategic and creative routes for top tow taglines

Red Peak (consultant) presented six creative routes. Three each for two taglines: "Find Your Mission Here," and "The Center of What's Possible." See presentation attached.

Overall, the group was pleased with the visual concepts presented. The group felt that "Find your Mission Here" was expressive, personal and made a connection with the physical mission in Santa Clara. The style of communication is focused on individual and different types of people finding different personal missions.

Option 1 was the most liked by the group. It was noted by several members that it was the safe route. However, some felt the font for some of the creative was difficult to read and would be hard to recognize in certain places such as street signs.

Option 2 of "Find your Mission Here" was felt by many to be difficult to understand or identify that it is the geographic shape of the city, although it was acknowledged that the concept was an astute representation of the marketing strategy. Red Peak felt the design defined our area, created a shape that was powerful to identify our city limits and educational. Red Peak saw it as the fingerprint or DNA of Santa Clara and noted that the color scheme was inspired by our local mission and adobe mission style red roof tops.

Option 3 was well perceived as modern and fun but many felt it was too playful and Disney-like. Overall, the group felt it was too childlike to attract businesses and promote economic growth.

Option 4 was not liked as many felt is too busy and difficult to read. The consultant explained that the idea behind this creative design focused on the theory of being in the "center" and the visual was to represent two ideas coming together. The group did like the idea of different colors for departments which was explored in this option.

Option 5 was highly preferred when it was paired with an image of people but there was some concern that without a person, it may not be the best fit. The consultant noted that this doesn't have to be the sole visual design and the group agreed it would be best to explore how it would look with other city related items such as architecture and businesses.

Option 6 was also found to be childlike. Some members of the group added that it was expressive and highlighted the city seal but the delivery was too loud for the majority of residents in the city.

3. Work Session

Outcome: The Marketing Committee narrowed the creative route to Option 1 of "Find your Mission Here" and Option 5 of "Center of What's Possible" to be explored for further development, addressing concerns about use of imagery, making the routes ownable and easy to implement. Red Peak also requested to come back with creative routes for Option 2 that addressed concerns about the map graphic being confusing or meaningless, to which the group agreed.

There is also a request to infuse the sentiment of the line "Center of What's Possible" into copy in the "Find Your Mission Here" routes. Red Peak as asked to return with creative that targeted residential, business and visitor audiences.
