This form is not interactive due to the requirement for an original signature. Please print, complete, then mail or deliver this form to the City.

To construct private underground lines within public right-of-ways, such as private communication lines, or private water discharge lines from a private remediation system designed to decontaminate a property, apply for a Street Encroachment License through the Engineering Department's Land and Property Development Division.

PROCEDURES FOR FILING

- 1. Fill out one copy of this Petition. If more space is needed, attach extra sheets.
- 2. Submit the following to the Engineering Department, 1500 Warburton Avenue, Santa Clara, California 95050:
 - a. Non-refundable filing fee contact Engineering Department at (408) 615-3000 for amount;
 - b. Five (5) copies of dimensioned plot plan (plot and profile is required) showing encroachment, with Petition attached; and
 - c. Written approval from private utility companies, as required. (Approval of City utilities will be processed by the Engineering Department.)
- 3. Prior to City Council action, applicant is required to provide a Certificate of Insurance.

FEE PAYMENT

Fee payment must be received by the City of Santa Clara before this form submittal can be certified as complete. Checks or Money Orders should be made payable to the City of Santa Clara and mailed or delivered to the Engineering Department, City Hall, 1500 Warburton Avenue, Santa Clara, California 95050. Credit card payments may be made via Visa, MasterCard, Discover, or American Express.
