- I. Call To Order The meeting was called to order at 10:01 am by Chair Pivacek.
- II. Roll Call All present.
- III. Introductions of Guests
 - A. Tom Freitas Community member
- IV. Approval of January 26 Minutes On a motion by Commissioner Estrada and seconded by Commissioner Collins, the Minutes of January 26 were amended. On a motion by Commissioner Estrada and seconded by Commissioner Buck, the amended Minutes of January 26 were approved.
 - I. Approval of the order of the meeting agenda On a motion made by Commissioner Buck and seconded by Commissioner Estrada.
- V. Correspondence/Communications None
- VI. Summary of City Council Actions Recreation Manager Patricia Lord informed the Commission that there was a second reading of the Park Impact Fee.
- VII. Commissioners' Reports -
 - A. Commissioner Kadlecek
 - 1. Encouraged the Commission to attend the Goal Setting meeting on February 23.

- 2. Reported that the cities of Portland and Austin are using mini house for homeless people.
- 3. Informed the Commission that tax services are going well. Commissioner Collins asked what the average income was of those that have utilized the service, and how many have been served. Commission Buck mentioned tax scams.

B. Commissioner Estrada

- 1. Informed the Commission that she was not able to attend the Mountain View Senior Advisory meeting, but would try and attend the next one.
- 2. Reported to the Commission facts about the Mountain View Senior Center and Senior Advisory Commission based on website research.
- 3. Reported that the City of Campbell does not have a Senior Advisory Commission.
- 4. Reported to the Commission, facts about the Campbell Senior Center based on website research.

C. Commissioner Orme

- Reported that the Age-Friendly City Committee met and will continue to gather information. The Committee will be contacting Patti Simoni from Santa Clara University to inquire about her knowledge of the certification. Commissioner Kadlecek shared information about an Age-Friendly City video from the Planning Department. Commissioner Estrada mentioned that the City of Mountain View Senior Advisory Commission was also working on becoming an Age-Friendly City.
- 2. Informed the Commission that he attended the Pedestrian Safety Workshop and reminded the group that when out walking you should wear light colored clothing so as to be seen by drivers. He also reported that there was a nice write-up in the Santa Clara Weekly.
- 3. Reported on his involvement with Leadership Santa Clara. The class was held at the Santa Clara Police Station. One of the topics discussed was in regards to homeless people in Santa Clara. Since the class, Sam was wondering more specifically about homeless seniors. Commission Diamond and Kadlecek suggested the County Poll for statistics. The Commission also discussed the closing of the mental hospital as a possible reason for the increase of homelessness.
- 4. Informed the Commission that he attended the Lollapalooza at the Central Park Library on February 8. The event was a fundraiser for the library with food and auction items.

D. Commissioner Diamond

- 1. Apologized for missing last month's meeting
- 2. Informed the Commission that a lawsuit was won with the help of AARP, regarding Homeowner's Association taking advantage of seniors.
- 3. Shared with the Commission that she is a member of the Santa Clara Rotary and mentioned that Rotary might be interested in getting together with the SAC to develop a partnership. One idea is to create a video for Senior Center patrons to be educated on the rolls of lifeguards in the Natatorium.

- Commissioner Buck suggested a partnership to help raise funds for the Health & Wellness Program
- 4. Reported to the Commission that she attended the Cypress Center meeting where they had a tight agenda, which was less formal, which involved a small group, and consisted of conversational dialogue. The meeting lasted for one hour and had a council member in attendance. Commissioner Estrada inquired about getting more information about the Senior Commission at the Center.

E. Commissioner Buck

- 1. Reported to the Commission that she visited the Sunnyvale Senior Center. In the center they have a store when patrons can buy home-made products that members sell. She informed the Commission that the structure is very different, that there is a fee to use the facility. Commission Buck will attend the Senior Advisory meeting in May and report back to the Commission.
- 2. Reminded the Commission about Jury Duty scams and encouraged them to be aware.
- 3. Stated that she likes the idea of Age-Friendly City and feels that it will make a difference.
