On Tuesday night, the City Council is voting on whether to instruct the City Staff to proceed with more detailed negotiations with the 49rs to construct a stadium.

This is my personal encouragement to attend the City Council tonight.
As you've seen in the papers and news last night and today, this is a big vote.

I personally support moving forward.

There will be a City-wide Vote.

I believe even the supporters, including those on the City Council, recognize that ultimately any proposal will go to the voters, so I'm not sure why they would not take things further.

Financial Diligence

The City Manager and staff, whom I always judge as extremely vigilant when it comes to financial matters, has recommended that the City continue discussions and more serious negotiations with the 49rs. They've stated and are aware that there is a funding gap beyond which they would recommend the deal, but believe there are possibilities in resolving that. (Again, wherever they end up, a vote will happen. We should put the best possible deal on the ballot and take the argument from there.)

Sensitivity to Neighborhood Concerns

- The **49r owners, John & Jed York** came out to our neighborhood last July and sat down over coffee (and cookies) at Joanne's house and spoke of their initial proposal and answered questions. To me that indicates sensitivity to Santa Clara citizens and neighborhoods. That

will be an issue here, as again everyone, including supporters, recognize there will be an impact to nearby neighborhoods on game & event days and must be addressed.

- Likewise, Council members who strongly support moving forward, including **Kevin Moore, Dominic Caserta and Mayor Mahan**, are the same people who've come out to our neighborhood sympathetic and helpful regarding our own concerns.
- Other Council members, whom I count on to carefully watch the numbers, **Jamie McLeod, Joe Kornder and Will Kennedy**, are also people who have visited our neighborhood, sensitive to our neighborhood concerns. I'm not sure where they'll end up on this vote, but am confident they'll be watching out for the numbers and the neighborhoods.

It will be an interesting night. It will provide insight into the judgments applied by the Council members and the diligence of the City Staff.

I am completely confident that both groups can take this opportunity further applying financial diligence and sensitivity to the impact on citizens and neighborhoods.

I encourage neighbors to attend and express our confidence that City Council members and the City Staff can and should take this further. It is a potentially large opportunity for the City, an opportunity to, though indirectly, boost sales tax revenues that provide monies that help fund projects such as our own street and sidewalk improvements. Applying redevelopment funds also opens up opportunities to increase, or provide earlier, funds to schools and other agencies providing services to us.

I encourage neighbors to attend and show support to move forward.
