SUBJECT: Correspondence Received Regarding the Proposed Football Stadium as of November 30, 2007

For the period of November 1 through November 30, 2007, the Mayor and Council Offices, City Manager's Office and other City departments and municipal addresses have received 123 additional emails, phone messages, and letters from residents or others regarding the proposal for a 49ers football stadium. The correspondence has been placed in Council Offices for review. The letters were in support, expressing concerns or opposition, provided suggestions or did not articulate a position. Some of the individuals forwarded copies of newspaper articles or reports. In some cases, multiple items of correspondence have been received from a single individual; for this reason, staff will continue to tabulate the total amount of correspondence received, but will not count the numbers of items in support, expressing concerns or opposition.

For public clarification, correspondence is provided to the Mayor and Council, and City Manager, shortly after receipt. Correspondence is being acknowledged by staff as time permits. Correspondence is placed into the public record through these periodic Agenda Reports.

Dear Ms. Sparacino and Ms. McCarthy,

Thank you so much for your efforts to provide information and analysis of the stadium subsidy issue.

I had several questions regarding information presented in the recent RDA and Stadium Authority presentations at City Council. I called your office with one of the questions last week, but I have not yet heard back. If you could provide any answers to these questions, I would be very grateful.

1) The RDA consultant said that certain pass-through payments (including payments to the school district) would begin immediately if the City passes an SB 211 amendment in order to issue new bonds in the North of Bayshore RDA district.

If so, how would these pass-through payments impact the current RDA budget and the proposed new budget with new bond payments? Are these pass-through payments high enough to limit the RDA's bonding capacity because of budgetary restraints?

2) The RDA consultant said that if the City issues the maximum possible in new bonds, the RDA district would hit its \$1.2B lifetime spending limit [I'm not sure if that's the right term] in 2025 -- one year before the bonds are repaid.

If so, what entity will make the payments in that final year? I followed up with the consultant on this issue after the meeting, but he had only a very general answer.

3) The RDA consultant said that his firm was asked to revise the projections using a "planning scenario" which envisioned a 5% annual increase. Is this an increase in taxes collected?

If so, how realistic is this level of growth in the proposed area? What are the historical trends? Does the limit on available land impact the potential for increased revenue growth? How was this "planning scenario" developed?

4) If the "planning scenario" is overly optimistic and tax revenues do not increase at the anticipated rates, what happens if the RDA is unable to make its bond payments? Do bond holders have rights to collect the

money they are owed?

5) Regarding the Stadium Authority, what happens if the SA loses money? I understand that the 49ers have suggested that they might be willing to cover stadium operational shortfalls in connection with NFL game day operations, but what if these contributions fail to cover the Stadium Authority's annual shortfall?

For example, if the Stadium Authority can't pay the bill for utilities or police service, how will these city agencies cover the costs?

6) In last week's presentation, the estimate was that the Stadium Authority bonds would be just one step up from junk bonds, so they would probably have a fairly high interest cost. If the Stadium Authority defaults on these bonds, do these bond holders have any rights to collect the money they are owed?

7) While we've seen what total subsidy request is [\$222M], what is the total the City and City agencies would spend in cash PLUS interest on the borrowed amounts?

Thank you in advance for your time and consideration. I look forward to your reply.

Hi Ms. Parrot, Ms. McCarthy, Mr. Garratt & Ms. Sparacino,

Thanks again for all of your efforts and the efforts of all of City Staff to try to provide meaningful and useful analysis on the extraordinarily complex issues around the proposed stadium subsidy.

Regarding the Nov. 20th meeting on RDA bonds. I understand that the bond consultants were unable to complete their presentation in time to post it prior to the meeting, and am glad to see it posted now. I really like the organization and ease of use of the new repository for these presentations at:
http://santaclaraca.gov/city_gov/49er_stadium_proposal.html

I have a follow-up question on the RDA presentation, that will be key in assessing the overall feasibility of this proposal.

My understanding from Tuesday was that the analysis was revised upward based on a more optimistic view of the business real estate market. However, as we all know, you can not predict the economy's behavior with 100% accuracy. The premise of a tax increment bond is that you are borrowing against a presumed increase in property taxes.

My question is:

What happens if that increase in property values (and subsequent increase in property taxes) do not materialize?

Is the city ultimately responsible for these bonds? If so, what priority does repaying those bonds take above other city expenses and responsibilities?

As you know, the revision was based on an assumption of strong growth in the real estate market. However, some analysts see signs of a poor economy -- according to an article in today's SJ Mercury News, the economy could approach zero growth due to the real estate crisis brought on by overly optimistic borrowing in the housing market.

Understanding the actual risk ultimately held by the city will help Santa Clarans in assessing the overall feasibility of the subsidy proposal.

Symptoms of a slowdown: Foreclosures rise as adjustable-rate mortgages reset
FORECLOSURES RISE AS ADJUSTABLE-RATE MORTGAGES RESET

NEW YORK - In the months ahead, millions of adjustable-rate mortgages will reset, giving them a higher interest rate as required by the loan agreements and leaving many homeowners unable to make their payments. Soaring mortgage default rates this year already have shaken major financial institutions, and the fallout from more of them, some experts say, could spread from those already battered banks into the general economy.

"We haven't faced a downturn like this since the Depression," said Bill Gross, chief investment officer of PIMCO, the world's biggest bond fund. He's not suggesting anything like those terrible times - but, as an expert on the global credit crisis, he speaks with authority.

"Its effect on consumption, its effect on future lending attitudes, could bring us close to the zero line in terms of economic growth," he said. "It does keep me up at night," he said.

Some 2 million homeowners hold \$600 billion of subprime adjustable-rate mortgage loans, known as ARMs, that are due to reset at higher amounts during the next eight months. Subprime loans are those made to people with poor credit. Not all these mortgages are in trouble, but homeowners who default or fall behind on payments could cause an economic shock of a type never seen before.

The already severe housing slump would be exacerbated by even more empty homes on the market, causing prices to plunge by as much as 40 percent in once-hot real estate spots such as California, Nevada and Florida. Builders like Chicago's Neumann Homes, which filed for bankruptcy protection this month, could go under. The top 10 global banks could suffer far greater write-offs than the \$75 billion already taken this year.

Massive job losses would curtail consumer spending that makes up two-thirds of the economy. The Labor Department estimates almost 100,000 financial services jobs related to credit and lending in the United States have already been lost, from local bank loan officers to traders dealing in mortgage-backed securities. Thousands of Americans who work in the housing industry could find themselves on the dole. And there's no telling how that would affect car dealers, retailers and others dependent on consumer paychecks.

Based on historical models, zero growth in the U.S. gross domestic product would take the current unemployment rate to 6.4 percent. That would wipe out about 3 million jobs from the economy, according to the Washington-based Economic Policy Institute.

By comparison, in the last big downturn from 2001 to 2003, about 2 million jobs were lost, according to the Labor Department.

Borrowers who took out loans in the first six months of this year are already falling behind on their payments faster than those who took out loans in 2006, according to a report from Arlington, Va.-based investment bank Friedman, Billings, Ramsey. That's making it even

harder for would-be buyers to get new mortgages - a frightening prospect for home builders with projects going begging on the market, and for homeowners desperate to unload property to avoid defaulting on their loans.

Meanwhile, the number of U.S. homes in foreclosure is expected to keep soaring after more than doubling during the third quarter from a year earlier, to 446,726 homes nationwide, according to Irvine-based RealtyTrac.

That's one foreclosure filing for every 196 households in the nation, a 34 percent jump from just three months earlier.

Such data suggests more Americans could lose their homes than ever before.

Some home buyers gambled on interest-only loans. The mortgages, which allowed buyers to pay just interest at a low rate for two years, were too good to pass up. But with that initial term now expiring, many homeowners find they can't make the payments. The hopes that went along with those mortgages - that they'd be able to refinance because the equity in their homes would appreciate - have been dashed as home prices skidded across the country.

"It's been said that a lot of people have been using their homes as ATM machines," said Thomas Lawler, a former official at mortgage lender Fannie Mae who is now a private housing and finance consultant.

This example illustrates the distress many homeowners are in or will find themselves in: A subprime adjustable-rate mortgage on a \$400,000 home could have payments of about \$2,200 a month, with borrowers paying 6.5 percent, interest only. When the teaser period expires, that payment becomes \$4,000, with the homeowner paying 12 percent and now having to come up with principal as well as interest.

Minneapolis resident Chad Raskovich found himself in such a situation. He hoped - it turned out, in vain - to gain more equity in his home and that a strong record of payments would enable him to secure a better loan later on.

"It's not just me, it's a lot of people I know. Now we're just looking for a solution," he said.

The Santa Clara City Council's capacity for irony is limitless. In its drive to wring out any potential source of funding for the \$222 million subsidy, not even the most essential of our monies is off limits.

On Tuesday, November 20, 2007, at the behest of the Santa Clara City Council, Consultants will report on how much of the City's bonding capacity, dedicated to providing affordable housing in our city, can be re-directed to the billionaires subsidy request.⁹ This is no April Fools day joke. Money which would otherwise support the affordability of rentals and home ownership in our City are targeted.

How much of your money for this essential program would be so diverted? According to the City Staff's report, \$65 million assuming our affordable housing goal is reduced 13%.¹⁰

To appreciate the crushing blow the proposed reduction in our City's commitment to affordable housing represents, we need to know a little about Santa Clara and the people who live here.

According to the 2000 census, there were 39,630 housing units in Santa Clara. Of those, 53.9% were renters, 46.1% were owners.^{11 12}

Between July 1997 and May 2001, the median housing price rose from \$319,950 to \$561,350, a 75% increase. During the same period, rents increased 64%. Incomes, of course, did not increase at anywhere near the same rate.¹³

The current City of Santa Clara General Plan concludes, "As a result, low and moderate income families were priced out of housing ownership."¹⁴

The General Plan's conclusion, while technically correct, overlooks a more important companion conclusion. Santa Clarans were not merely priced out of home ownership, they were forced out of their own community.

So, when we speak of "moderate" and "low" income families, who are we talking about?

According to the City's General Plan, "moderate" income families had an income of between \$69,051 - \$104,760 in 2001. "Low" income families made between \$43,651 and \$69,050 in the same year.¹⁵

These are the families that the City's affordable housing programs are intended to protect. Again, according to the City's General Plan, "RDA funding [yes, the same source the 49ers would like to raid] has become the largest steady source of affordable funding in the community."¹⁶

So, how does the crisis in affordable housing come about and how does it directly affect me and my family, friends and neighbors?

Housing is considered "affordable" when a household pays less than 30% of its gross monthly income for housing, including taxes and insurance (and utilities, for rental housing).¹⁷ Why do people overpay? A few, certainly by choice. The overwhelming most because they have to, that is, there is not a sufficient number of affordable units, so they have to stretch it, resulting in living on the edge at best, and too often, cruel hardship.

The City of Santa Clara's most recent General Plan (2001) reports that 23% of Santa Clara owner households are overpaying, that is spending more than 30% of their income on housing.¹⁸

37% of renters¹⁹ are overpaying.²⁰

60% of elderly (65 and older) renters are overpaying.²¹ Of all elders, population of 10,900 in our City, 7.9% were below the poverty line. The elderly account for 17% of all Santa Clara heads of households.²²

30% of the 4,162 households with a disabled family member are overpaying. Households with a disabled family member account for 10.5% of all Santa Clara households.²³

9.5% of Santa Clara households (3,659) are headed by a female householder. 45% of those

households have children at home.²⁴

30% of all Santa Clara households earn less than \$50,000 per year.²⁵

These facts, and the people who live them, are the reason affordable housing is so essential for all of us. Look again at the numbers. The people. They are many of us. For the rest, it is a reminder that we are all one divorce, one death of a bread winner, one illness, one accident, one "job restructuring" or one occurrence of random bad luck, away from being booted from our own community.

Maintaining a strong commitment to affordable housing, and the city redevelopment monies that fund it, are the only tools we have, to, as best we can, take care of our own and keep some feint hope that our children, might have some chance to live in their own hometown.

The final point which must be addressed, is to identify how Santa Clara is performing on its commitment to us and our children, to provide affordable housing. Here is the answer, direct from the City's General Plan.²⁶

In terms of meeting our City's affordable housing goal (Very Low, Low and Moderate incomes) for the period above, we needed to build 3,670 new units. Built were but 109. We missed target by 2,970%.

In relation to the \$65 million in RDA monies, sought to be raided by the 49ers, perhaps it is enough to say "no." We have much more important needs for those monies.

Then again, with a City Council devoid of a sense of irony, and apparent disdain for community needs, (that is, what part of "Residents come first!" don't they understand?) you just never know.

Dear Ms. Sparacino:

On June 15, 2007, Ms. Karen Hardy and I submitted a ballot proposal for action by the City Council relating to the funding of any proposed football stadium in Santa Clara. Your letter of June 18, 2007 responded that our proposal would be presented for action by the Council on the agenda at the next regularly scheduled council meeting following presentation of the completed Stadium Feasibility Study.

Since submission of our proposal, which contemplated the stadium funding measure being placed on the February 5, 2008 ballot, two significant developments have occurred which necessitate a change in the election date, presuming our request is acted upon favorably by the City Council.

First, the Stadium Feasibility Study process was targeted by the 49ers to be completed by the end of July, 2007. Our most recent information from the City suggests the study will not be presented before December, 2007.

Second, the Guiding Principles, in relevant part, provide that (1) Cedar Fair must agree to and cooperate with any proposed stadium project and, (2) the City requires a written acknowledgment from Cedar Fair stating they will not assert various business interference claims arising from the feasibility study process and/or discussions with the 49ers. As of the date of this letter, it is undisputed that Cedar Fair is on record as opposing the stadium project and no written agreement, which was an express condition precedent to commencing the feasibility study process and/or discussions with the 49ers, has been obtained.

Because of the developments identified above, we presume that no stadium proposal, as contemplated by the Guiding Principles, can go forward until (1) the written agreement is made with Cedar Fair, (2) Cedar Fair drops its opposition to the stadium and (3) the feasibility study process is complete. If our presumptions are in error in any respect, please notify me at your earliest convenience.

Therefore, we have amended our agenda item request to reflect an election date for any such Stadium Funding Measure from February 5, 2008 to November 4, 2008. Of course, in the event that the feasibility study process is completed, a proposal negotiated, written agreement with Cedar Fair is made, and Cedar Fair reverses its opposition to the stadium, all occurs in time for the matter to be placed on the June 3, 2008 ballot, the Stadium Funding Measure date would be automatically adjusted to the June 3, 2008 election, if the Council so decides.

For good order sake, therefore, we hereby set forth our proposal for Council action with the amendment of the election date only.

1. The Santa Clara City Council commit that any proposal involving the appropriation of any City, City agency, City authority or City Utility monies, property or indebtedness, for the construction and/or operation of a football stadium, be submitted to the votes of Santa Clara for final approval or rejection. This vote shall be binding and not advisory.
2. The Santa Clara City Council direct that the Stadium Funding Measure be placed on the November 4, 2008 general election ballot.
