**Matters for Council Action:** None

1. **Call to Order.** The meeting was called to order by Superintendent Stanley Rose III at 7:31 a.m.
2. **Approval of Minutes.** The minutes were not approved as corrected. They will be postponed until the December meeting. Dr. Rose will work on the wording acceptable by both groups.
3. **Community Comment.** There was community comment on the Martinson Development

Center along with the conditions of the fields at both high schools.

4. **Firehouse Run.** The Firehouse will take place on December 4, 2016. There is an executed agreement with the City and the School District
5. **Bellomy Tennis Courts.** The City Council has allocated \$200,000 toward the renovations and hopes the District can allocate the same amount. Larry Adams will set up a meeting with the City to go over some conceptual plans.
6. **New Development.** Recent project approvals include a subdivision for a commercial development at Mission College and Homestead Road. The Final Environmental Impact Report (FEIR) for the Lawrence Station Area Plan has been posted on the City's website. Teresa O'Neill reported that Summer Hill would like to meet and talk with her. Mark reported there has been several meeting with Summer Hill and asked the same questions as others.
7. **Student Notification.** Chief Sellers voiced a concern on how to get the word out to students or families as they have had little participation in activities from families when they are giving donations away. Concerned since the District has gone to Peach Tree the word doesn't seem to be getting to the parents. Andrew Lucia will follow up with principals and David Torres, Director of Human Resources. He will also get standardized information out to communities on how to get the information to schools and parents.
8. **Rising Readers.** Kathie and Lori reported out about the launch for early literacy with Footsteps2Brillance. The event was well attended with over 100 guests. They meet every two months at the library. As of this meeting date the students have read over 1.8 million words which is over the challenge set. This is a very unique program in the country.
9. **International Swim Center.** A concern was voiced on the children walking to Central Park Elementary from the neighborhood that would use the bridge. It was suggested that the District send a plan for the safe route to school and the City will review it.
10. **Safe Routes.** Discussion on when the crosswalks in front of Wilcox High School and Santa Clara High School will be put in. There are no specifics at this time and the details are being worked on.
11. **Report Overview of UC Santa Cruz Silicon Valley Campus.** A meeting took place with the campus which is located in Santa Clara Square. Courses offered for post graduate will not do much for District students but there might be an opportunity for students in our district. They may be offering online courses and some are free for students. There will be conversations on A-G and UC approved courses along with a variety of other course.
