1. Call to Order/Roll Call

Meeting called to order at 7:10 p.m.

2. Public Presentation

Balraj Singh presented a summary of Joy of Sewa's (JOS) Sikh Awareness Month activities. Theme was Humanity and Service and they held one event every week. The closing celebration at Don Callejon had approximately 450 attendees. The Solidarity Turban Fashion Show included leaders from Santa Clara. The Peace Tree built at the Closing Celebration will be presented at a Council Meeting in December. Over 300 pounds of food was collected for Second Harvest, over 9000 meals packed at Kids Against Hunger, and over 75 families served at the Love a Child Mission. Funds were raised at the closing celebrations for local Silicon Valley and Santa Clara nonprofit organizations and foundations such as the Library Foundation. JOS will present plans for 2017 in the near future. JOS gave thanks to the Cultural Commission (CC) for their support and collaboration.
