Amendment to the existing Planned Development Zoning of the 5.8-acre site to allow the construction of a residential mixed-use development consisting of: up to 419 mixed income housing units, 165 affordable senior apartments, and up to 25,000 square feet of supporting commercial uses, and approximately 1.5 acres of agricultural and open space. Approval of the proposed PD Rezone Project will require actions by the City of Santa Clara, including the

preparation and certification of an Environmental Impact Report (EIR).

As the Lead Agency, the City of Santa Clara will prepare the EIR for the above-referenced Project. The City is seeking comments from Responsible Agencies and the public as to **the scope and content** of the environmental information that should be considered for inclusion in the EIR for the proposed project.
