- **A.** Mr. Jain announced that there will be a presentation on "Grand Boulevard" at Santa Clara University on June 28<sup>th</sup> for those interested in attending.
- **B.** Mr. Jain noted that the bike lanes on Homestead Road disappear east of Scott and adjacent to a park for a distance of about ¼ mile. He would like to see if it would be possible to remove parking next to the park and add in bike lanes along this stretch of Homestead Road.

  - 1. Staff will make recommendations to City Council in July along with cost estimate to mitigate the pinch point on Pruneridge Avenue at Lawrence Expressway.
  - 2. After being directed by City Council to study alternative detour routes, staff will present 4 options at City Council meeting on July 11th.
  - 3. There will be a special BPAC meeting on September 20<sup>th</sup> concerning the Creek Trail Master Plan. The consultant will present their preliminary plan.
  - 4. The Bike Plan RFP is being reviewed by Attorneys Office and will soon be ready to post.
- **D. VTA BPAC Update** Member Peters attended meeting in April and May. She updated the committee on Measure B funding allocations.
- E. BPAC Subcommittee Operations No update
- **F. BPAC Subcommittee Bronze to Silver** Member Kratz noted that they have prepared a comparison of Santa Clara's safe routes to school efforts with those of other cities. He was willing to assist in filling out any future safe routes to school applications.
- G. Vision Zero Colin Heyne Silicon Valley Bicycle Coalition President provided an overview of the different approaches cities have taken to enact Vision Zero policies or goals. He noted that some have hired consultants while others have hired additional staff to develop and manage the process. Cities enacting these policies where generally larger Cities like San Francisco and San Jose and the approach taken varied. It was recommended to the Cities Bike Plan and to search for grant funding as first steps. He also recommended getting the City Council on Board during initial phase.

H. Bikes on Sidewalks – After looking at similar ordinances from surrounding Cities, members ultimately decided it preferred an ordinance similar to the one enacted in the City of Sunnyvale. It was suggested that the committee reach out to the Senior Advisory Committee for their input before moving ahead with any changes.

**A. City VTA BPAC Representative** – Chair O'Neill led discussion concerning filling the vacancy for the City's VTA BPAC representative when Sara Peters relocates out of state in August. Member Kratz motioned with 2<sup>nd</sup> by member Harrison to nominate Thomas Granvold to City Council as the City's representative on the VTA's BPAC. Members unanimously approved motion.

The club operated a twice-monthly bicycle repair clinic for the youth of that city at no charge to the participants; over 4,000 participants attended in that period. Club members, all volunteers, assisted youths in the repair and maintenance of their bicycles as well as taught riding skills. Repair procedures were accomplished by reusing used bicycle parts by salvaging bicycles that were headed for the dump. The club also attended and helped at bicycle rodeos and parades sponsored by that city. The club attended and provided logistical support for a bicycle reuse event sponsored by the County of San Mateo. Our club's achievements were recognized by the City of East Palo Alto and County of San Mateo. I have attended City of Santa Clara Bicycle Advisory committee meetings occasionally in the past since the inception of the committee.

Subject: Transportation Fund for Clean Air (2018/19) Grant Application Recommendations (Item 5B)

The Santa Clara Valley Transportation Authority (VTA) will be putting out a Call-for-Projects in December for 2018/19 Transportation Fund for Clean Air (TFCA) 40% Program Manager grant applications. This program is funded by a \$4 surcharge on motor vehicles registered in the Bay Area and typically has \$2.5M - \$3M funds available annually. The grant applications historically have been due in March 2018.

Applicants with bicycle projects can either receive funding from the Bicycle Expenditure Program (BEP) set-aside or from the competitive funds. Bicycle projects must be listed in the City's or VTA's current Bicycle Plan to be considered for funding from the BEP set-aside. Last year, the Bicycle and Pedestrian Advisory Committee (BPAC) prioritized (in preferred order) street segments for bicycle facilities; Mission College Boulevard (Western City Limits to Great America Parkway), Mauricia Avenue (Cronin Drive to San Tomas Expressway), Benton Street (Monroe Street to El Camino Real) and Lafayette Street (Laurelwood Road to Central Expressway) for staff to consider applying for TFCA funds. The Mission College bicycle lane project was submitted and recommended by VTA for \$109,500 of grant funding by TFCA.

Members will review possible locations for bicycle facilities and recommend potential projects for Staff to submit applications for funding based on the City's Bicycle Plan.

**Subject:** 2018 Slurry Seal Street List (Item 5C)

Each year the Public Works Design Division establishes a list of streets for preventative maintenance treatment for that fiscal year. Last year the bids received for that 2017 slurry seal/cape seal project came in too high and the City decided not to award the construction contract for the Project. The 2017 Project will be rebid this fiscal year with a few changes to the list of streets (see attached 2017 Slurry Seal List). In the BPAC's review of the 2017 list of streets for Slurry Seal/Cape Seal/AC Overlay, the Committee prioritized Bowers Avenue (Cabrillo Avenue to El Camino Real), Pruneridge Avenue (San Tomas Expressway to Winchester Boulevard), Lick Mill (Tasman Drive to Montague Expressway) and Agate Drive (French Street to Bowers Avenue Ped Bridge) for possible implementation of bicycle facilities.

In the January 2018 BPAC meeting, staff anticipates to bring a new 2018 list for the committee to review and recommendation on candidate streets for adding in bicycle facilities.

Bicycle and Pedestrian Advisory Committee members will review this list for the purpose of selecting possible additional streets that they would recommend as candidates for adding bicycle facilities if desired based on the City's Bicycle Plan.
