- A. Guadalajara Guadalajara Danielle Aguillar and Obudia Esparaza
 - i. This is a travelling group that is coming to Santa Clara University but there are conflicts with August 18, 2017.
- B. Joy of Sewa Partnership for S.A.A.M.
 - i. Joy of Sewa presented last year's summary. There was positive response from the community. They were requested to come back again this year for more, and also to consider participation in Tree Lighting activities. The group presented their 2017 Plan and requested Cultural Commission to co-sponsor the events. No funds were requested. They only want the Cultural Commission to co-promote as a sponsor/partner, and support if and when needed with venues, programmatically, City etc. Co-sponsoring marketing would be the same as last year: website, digital billboard, on highway 101, electronic billboard on 237. They are coming in advance to start publicizing.
 - ii. For Dec 1st Tree Lighting, JOS would like to participate as a part of the festivities per the request last year, vs. having a separate event. They can provide dance performances, booths and activities, etc. They would like to have 2 booths if possible for interactive activities, etc. Cultural Commission would like them to provide the cultural performances, like the Hip Hop Bhangra.
 - iii. Action Item for Staff Liaison: Cultural Commission wants clarification about how much time is slotted for the performance and to how to proceed. Either Cultural Commission should connect Joy of Sewa to Parks and Rec Commission or Joy of Sewa will reply to Roseanne and cc Staff Liaison.
 - iv. Volunteer at the Art and Wine event: Joy of Sewa volunteers agreed to help man the booth at Art and Wine Festival. Staff Liaison to provide information on the logistics. Motion was unanimously approved.
