Public Presentations

- Members of the public are provided an opportunity to directly address the Board, Commissions or Committee on items of public interest that are within the jurisdiction of the Board, Commissions or Committee, and any item listed on the agenda.
- For meetings held in the Council Chambers, please note the speaker timing lights located on the podium. A green light indicates the beginning of the time period, a yellow light will appear when 30 seconds remain, and a red light will appear and a buzzer will sound at the end of the time period.
- Groups are encouraged to appoint a single spokesperson, but all speakers should avoid repetitive comments.
- You may be requested to fill out a speaker card and/or give your name when you speak, but are not required to do either to address the Board, Commissions or Committee.
- Please note that the Board, Commissions or Committee cannot take action on an item of business not appearing on the agenda. The only exceptions are if the Board, Commissions or Committee determines that one of the following emergency situations exist:
- Work stoppage or other activity which severely impairs public health, safety or both, as determined by a majority of the members of the Board, Commissions or Committee; Crippling disaster which severely impairs public health, safety, or both, as determined by the majority of the Board, Commissions or Committee; or Upon a determination by a two-thirds vote of the Board, Commissions or Committee, or, if less than two thirds of the members are present, that the need to take action arose after the agenda was posted; or the item was posted for a prior meeting of the Board, Commissions or Committee occurring not more than five (5) calendar days prior to the date action is taken.
- In the event of a public presentation, the Board, Commissions or Committee or its staff may briefly respond to statements made or questions asked, or may proceed to the next item of business or adjourn. The communication not acted on shall be accepted by the Board, Commissions or Committee for placement on the agenda for the following Board, Commissions or Committee meeting, if requested by the citizen.
- Electronic presentations should be submitted to the liaison department to enable screening for compatibility and viruses. Contact the liaison department to ascertain when the material should be submitted.
- Written materials should be submitted to the liaison department to allow the City to copy such materials. Contact the liaison department to ascertain when the material should be submitted. 1. Call to Order/Roll Call

The meeting was called to order by Chair Bobbie Estrada at 10:05 a.m.

2. Approval of the Agenda

On a motion by Commissioner Buck, and seconded by Commissioner Toledo, the Commission approved (6-0) the order of the agenda.

3. Approval of October 23 meeting minutes

On a motion by Commissioner Orme, and a second by Commissioner McCauley, the Commission approved (6-0) the minutes for the regular meeting.

4. Correspondence/Communications -

- A. Supervisor Herb shared an eNotify with the Commission regarding Preventing Package Thefts during the holiday season.
- B. Supervisor Herb informed the Commission about an upcoming Website Redesign Community Meeting on November 30, 2017, at the Senior Center, from 5:30 6:30 p.m.
- C. Supervisor Herb shared additional information regarding the Santa Clara Police Department City-Wide Survey. The full report will be released to City Council in May/June 2018. The year-long process will include the survey as well as community panel and focus groups.

5. Old Business

- A. Commission Fiscal Year 2017-18 Work Plan & Goals
 - i. Support Health and Wellness Fair (Commissioner McCauley) Supervisor Herb informed the Commission that Save the Date emails are going out to the list of resource vendors that participated last year, as well as new vendors. Staff is utilizing

- the Age-Friendly domains as a guide to ensure that all areas are covered by resource vendors. Supervisor Herb confirmed with the Commission that they are interested in being greeters and Event Hosts during the event, as well as assisting with marketing.
- ii. Champion Age-Friendly Initiative (All) Recreation Manager Castro shared that Santa Clara County is the first county to have all its cities recognized as Age-Friendly. There will be a Senior Needs Assessment meeting at the beginning of January to go over key findings which will be reported at the January Senior Advisory Commission meeting. A meeting will then be scheduled with Community Partners to also go over the key findings.
- iii. Promote Elder Fraud Workshops Quarterly (Commissioners Estrada/Garcia) Supervisor Herb was able to secure a speaker for a Careful Consumer Presentation on Friday, December 15, 2017, at 10:30 a.m. The speaker is from the Santa Clara County District Attorney's Office. Commissioner Garcia shared a link to a 3-minute video from the Elder Fraud Department.
- iv. Develop opportunities to promote Brain Health for seniors (Commissioners Orme/Buck) Commissioner Orme shared that he was able to secure the instructor from the Senior Center Mindfulness class to offer mindfulness exercise at the Health & Wellness Fair. Commissioner Buck shared that she is able to use mindfulness to help manage pain. Commissioner Toledo asked that information be shared with the Senior Center patrons on a regular basis, through the Senior Center Newsletter or similar avenue. The Commission would like to discuss possibly collapsing the Brain Health goal into another goal at the January meeting.
- v. Represent Senior Advisory Commission on ADA Committee quarterly (Commissioners Toledo/Orme) next meeting is scheduled for December 14, 2017.

6. New Business

 - i. Senior Advisory involvement Commissioners McCauley, Seeger, and Toledo will be assisting in the Information Booths during the event.
- B. Discuss potential Intergenerational Panel in collaboration with Youth Commission Supervisory Herb shared with the Commission that the Youth Commission is interested in co-hosting an intergenerational panel discussion with the Senior Advisory Commission in March. The Senior Advisory Commission expressed an interest. Supervisor Herb will follow up with Youth Commission Staff Liaison Jon Kawada.

A. Recreation Supervisor Herb reminded the Commission that the Holiday Tree Lighting event will be on Friday at Central Park, and encouraged everyone to attend.
