- A. The Brown Act Presentation Diana Fazely, City Attorney's Office
 - Purpose of the Brown Act is to safeguard public's right to access and participate in government meetings within State.
 - Brown Act covers the Cultural Commission but not ad-hoc subcommittees
 - Four commissioners is considered quorum for a commission size of seven.
 - Last year Commissioner Bhatia received legal approval to use Google Drive for documentation repository.
 - There was discussion to understand policy and execution workflow policies under the Brown Act.
 - Google Docs for subcommittee planning (less than four commissioners) and repository usage is allowed.
 - Subcommittees will need to be for a duration of time (i.e. 2017).

Hello Cultural Commissioners,

Below is the proposed performer lineup for the Summer 2018 Concerts in the Park and Street Dance. Please review the bands before the Cultural Commission meeting on Monday October 2nd, which is when there will be a vote on approval of the dates and performers. Dates and details need to be submitted for printing in the Summer Activities Guide sometime in the next few weeks (it is printed and arrives in February), and also dates to be printed in the city calendar.

The criteria for the bands is wide appeal to a diverse population, and age range. Also, the bands need to have an established following and reputation in the South Bay, performing at the major festivals and community events. There were comments from community members to consider diversity in the makeup of the bands. If we happen to get bands that are themselves ethnically and sexually diverse, then great. It is in fact a consideration, but is not a primary criteria for the Summer Concerts. The proposed 2018 lineup is actually very ethnically and sexually diverse.

For diversity, we consider the makeup of the residents attending the events, and look for those attending to reflect the age and cultural diversity of Santa Clara. The Summer Concert programming is expected to have broad appeal to the diverse residents of Santa Clara. We have definitely succeeded in accomplishing that over the last few years, compared to the demographic of the attendees several years ago.

The budget for the Friday evening concerts has been for many years and continues to be \$3700 for the 4 concerts. \$3600 is currently allocated to pay for the 4 bands. The Cultural Commission re-allocated additional funds to pay for the Sunday concerts in 2017. \$1740 is currently needed for 2018 for 2 Sunday shows, with an optional 3rd Sunday if desired.

I'll be working on this with the Culturtal Commission until final approval. It has been challenging due to financial limitations, and better quality bands wanting higher pay and a sound engineer.

If needed, I can be at the Commission meeting Monday October 2nd to give detailed background information on the concerts, and answer any related questions. Just let me know.

Cost: \$1000

Base price was \$850. Last 2 years we added \$150 which would go towards them paying for a sound engineer, for a total of \$1000. They have requested some additional pay which would go towards the sound engineer. They were told that we would consider some additional pay when we see how much budget we have remaining after we have all of the bands are booked. Looking at paying them \$1100. Usually, at least 1 band each summer gets paid \$1100 for the Concerts in the Park (Houserockers or The Hitmen).
