#### **Public Presentations**

- Members of the public are provided an opportunity to directly address the Board, Commissions or Committee on items
  of public interest that are within the jurisdiction of the Board, Commissions or Committee, and any item listed on the
  agenda.
- For meetings held in the Council Chambers, please note the speaker timing lights located on the podium. A green light indicates the beginning of the time period, a yellow light will appear when 30 seconds remain, and a red light will appear and a buzzer will sound at the end of the time period.
- Groups are encouraged to appoint a single spokesperson, but all speakers should avoid repetitive comments.
- You may be requested to fill out a speaker card and/or give your name when you speak, but are not required to do either to address the Board, Commissions or Committee.
- Please note that the Board, Commissions or Committee cannot take action on an item of business not appearing on the agenda. The only exceptions are if the Board, Commissions or Committee determines that one of the following emergency situations exist: 1. Work stoppage or other activity which severely impairs public health, safety or both, as determined by a majority of the members of the Board, Commissions or Committee; 2. Crippling disaster which severely impairs public health, safety, or both, as determined by the majority of the Board, Commissions or Committee; or 3. Upon a determination by a two-thirds vote of the Board, Commissions or Committee, or, if less than two thirds of the members are present, that the need to take action arose after the agenda was posted; or the item was posted for a prior meeting of the Board, Commissions or Committee occurring not more than five (5) calendar days prior to the date action is taken.
- In the event of a public presentation, the Board, Commissions or Committee or its staff may briefly respond to statements made or questions asked, or may proceed to the next item of business or adjourn. The communication not acted on shall be accepted by the Board, Commissions or Committee for placement on the agenda for the following Board, Commissions or Committee meeting, if requested by the citizen.

- 1. Call to Order/Roll Call/Order of Agenda: The meeting was called to order by Chair LaCoursiere at 7:05 p.m. On a motion by Commissioner Walke and second by Commissioner Silva, the Commission excused Commissioner Martinez (5-0-1).
- 2. Approval of Minutes: On a motion by Commissioner Silva and second by Commissioner Walke, the Commission approved the January 2017 Minutes (5-0-1).
- 3. Correspondence & Communications: Recreation Manager Castro reviewed correspondence and communications with the Commission.

#### 4. New Business:

A. Review and Recommend to Council Approval of Schematic Design for a Mini Park located at 575 Benton Street (Presentation by Prometheus Development Director, Marilyn Ponte). After developer presentation and Commission discussion of park features and neighborhood support for a mini park, the Commission thought the public mini park was too small, features inadequate and not viable. On a motion by Commissioner Guerra and second by Commissioner Silva, the Commission recommended that Council reject the

- developer's dedication of a mini park and accept a fee in lieu of parkland dedication from the new housing development, located at 575 Benton Street (5-0-1).
- B. Review and Recommend to Council Approval of Central Park Master Plan Update Guiding Principles (Presentation by Gates & Associates Principal, Linda Gates). On a motion by Commissioner Silva and second by Commissioner Guerra, the Commission recommended that Council approve the Central Park Master Plan Guiding Principles as presented (5-0-1).
- C. Review and Recommend to Council Approval of Homeridge Park Updated Schematic Design and Playground (Presentation by Gates & Associates Principal, Linda Gates). On a motion by Commissioner Silva and second by Commissioner Walke, the Commission recommended that Council approve the Homeridge Park updated schematic design and playground (5-0-1).
- D. Consider Names to Recommend to Council for New Santa Clara Square Core Park and Creekside Park. On a motion by Commissioner Knaack and second by Commissioner Silva, the Commission tabled this item for the May Parks & Recreation Commission Meeting (5-0-1).
- E. Art & Wine Festival 2018 Planning Discussion: Wine, Beer, Glass, Promotional Artwork. The Commission discussed the need to include stemmed glasses, continue with the Mason jar mugs, and to have a bold and contemporary theme for the artwork.

On a motion by Commissioner Walke and second by Commissioner Guerra, the Commission recommended that reservations of Parks & Recreation Department facilities (such as group picnic areas, buildings, fields, etc.) be permitted up to 355 days in advance of an event (5-0-1).
