ADMINISTRATIVE CITATIONS (after Special Response Analysis):

- 10/15/2016 through 5/13/2017 = 56
- 10/15/2017 through 5/19/2018 = 31
 - (analysis of each showed that less gatherings warranted citations than previous year)
