

- Opening: Fall 2019





Student Safety

- Survey with Campus Safety Services
 - Continued work with CSS & Off-Campus Living to reach concrete solutions to issues reported by over 350 students
 - Includes a community lighting walk around to observe specific locations where students feel unsafe due to lack of proper lighting
