Subject: Reconsideration of Bicycle and Pedestrian Advisory Committee Membership Voting

The Bicycle and Pedestrian Advisory Committee (BPAC) membership is for a three year term and members can elect to serve additional terms if approved by current members of the Bicycle and Pedestrian Advisory Committee and the City Council. At the October 22, 2018 BPAC, since no new applications were received and the three current members that were terming out wanted to continue serving, the BPAC took action on this (Item 5A from the October 22, 2018 meeting) and recommended this to City Council. Subsequently, during the preparation of the report to City Council for this item staff discovered that although the positions were advertised through the Silicon Valley Bicycle Coalition (SVBC), they were not advertised through the City website or Channel 15 as stated in the memorandum to BPAC at the October 22 meeting. Staff, after consulting with Committee Chair ONeill, decided to readvertise for the open BPAC memberships on the City website, City channel 15, and on SVBC website and call a Special BPAC meeting so that any interested person who either works in or is a resident of Santa Clara may apply and be considered for the openings.

The membership terms for members Thomas Granvold, James Parissenti, and Don Sterk expire on December 31, 2018. Members will vote to fill the three open memberships.
