*\*\*Weekday shifts added as needed for preplanned events*

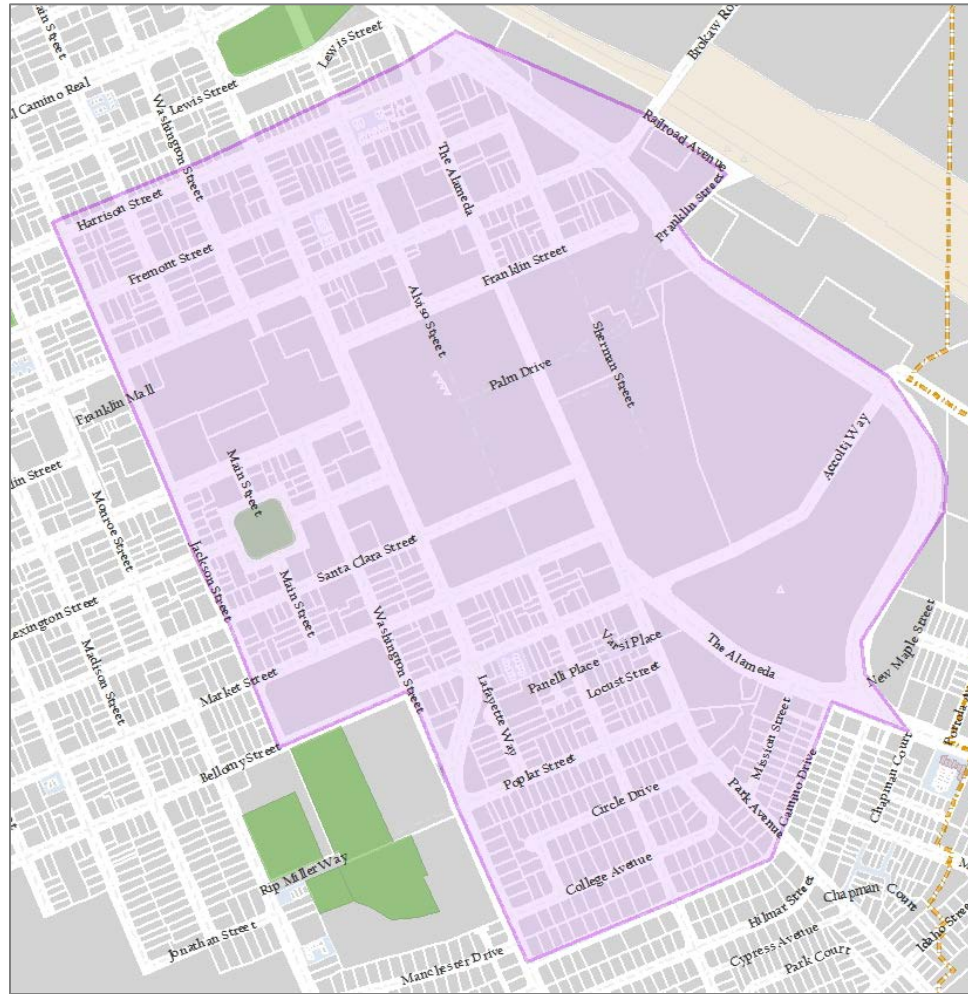
## Problem Area Saturation Patrols:

- ***9/1/2018 through 10/16/2018 = 7***

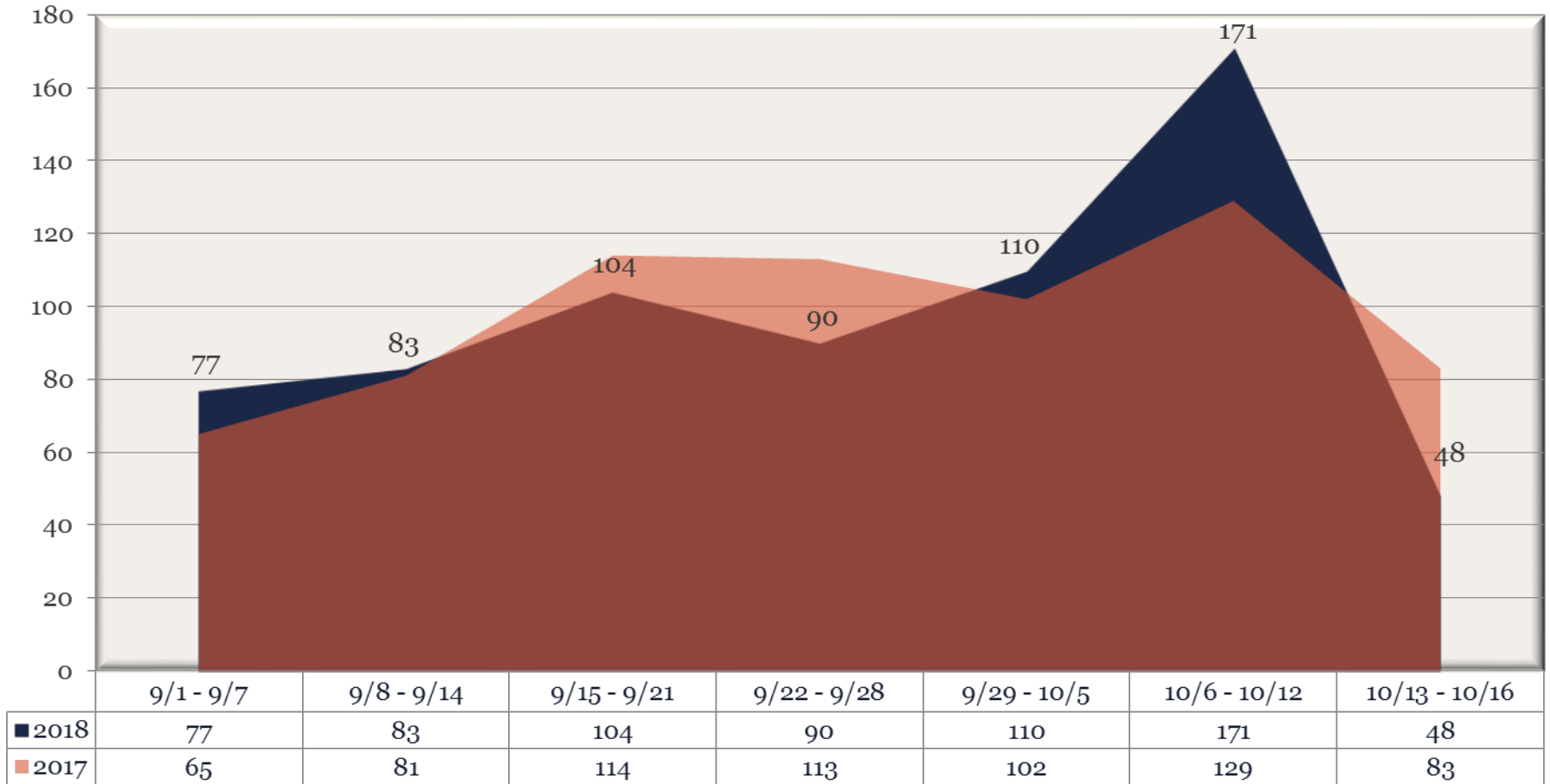
## SPECIAL RESPONSE NOTICES:

## ADMINISTRATIVE CITATIONS (after Special Response Analysis):

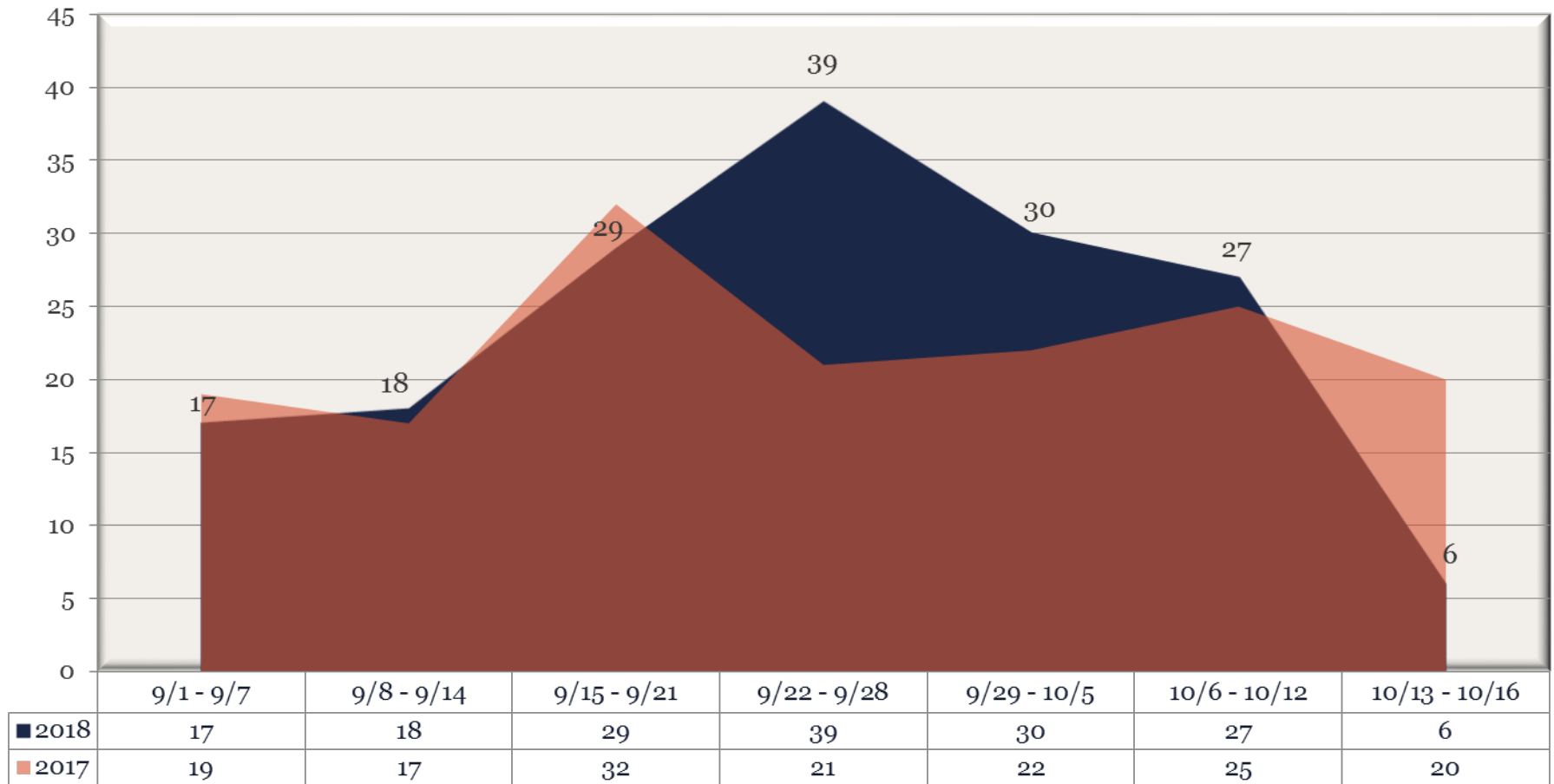

# SCU Calls for Service



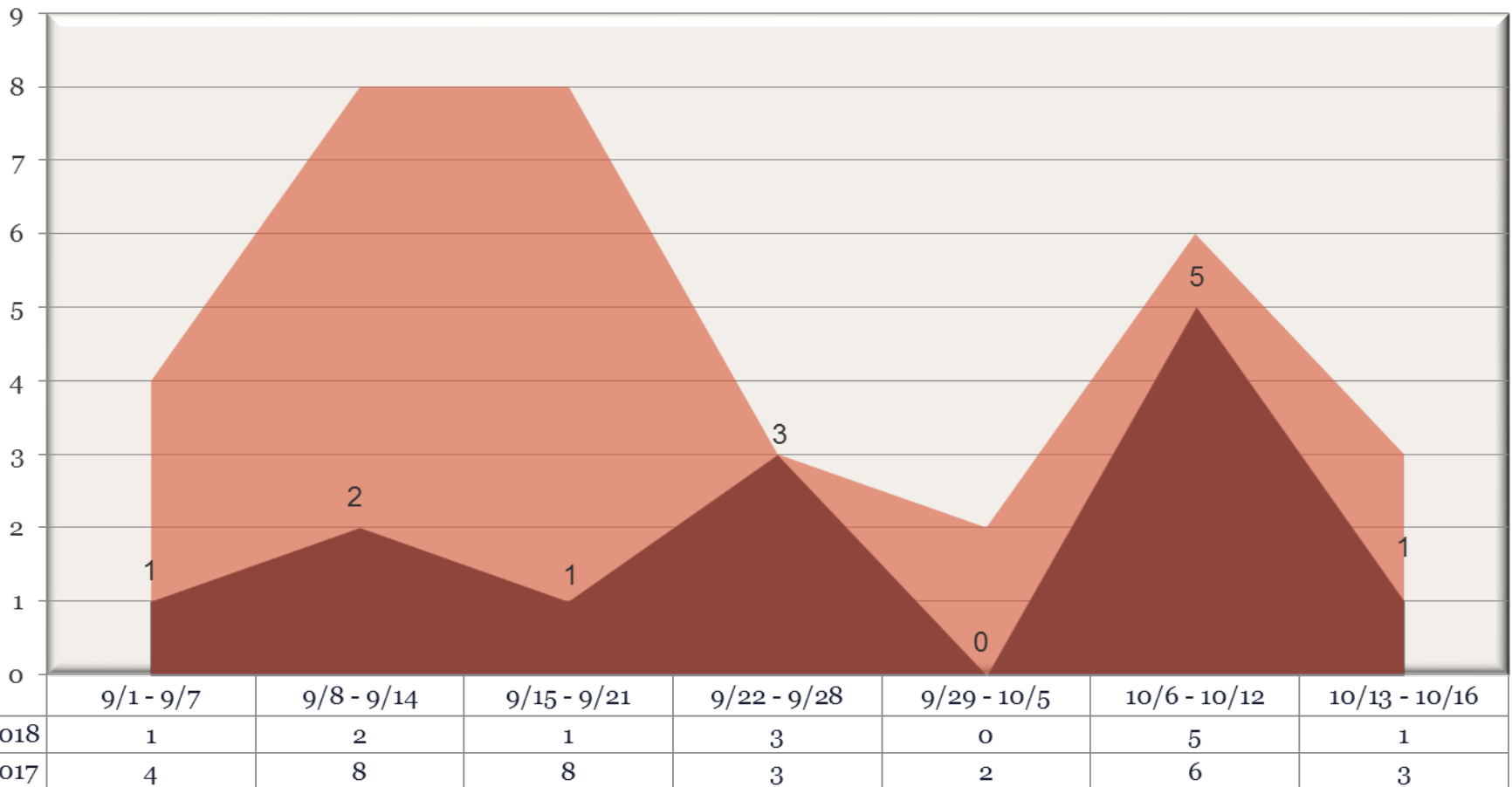
