You may be requested to fill out a speaker card and/or give your name when you speak, but are not required to do either to address the Board, Commissions or Committee. Please note that the Board, Commissions or Committee cannot take action on an item of business not appearing on the agenda. The only exceptions are if the Board, Commissions or Committee determines that one of the following emergency situations exist: Work stoppage or other activity which severely impairs public health, safety or both, as determined by a majority of the members of the Board, Commissions or Committee; Crippling disaster which severely impairs public health, safety, or both, as determined by the majority of the Board, Commissions or Committee; or Upon a determination by a two-thirds vote of the Board, Commissions or Committee, or, if less than two thirds of the members are present, that the need to take action arose after the agenda was posted; or the item was posted for a prior meeting of the Board, Commissions or Committee occurring not more than five (5) calendar days prior to the date action is taken. In the event of a public presentation, the Board, Commissions or Committee or its staff may briefly respond to statements made or questions asked, or may proceed to the next item of business or adjourn. The communication not acted on shall be accepted by the Board, Commissions or Committee for placement on the agenda for the following Board, Commissions or Committee meeting, if requested by the citizen. Electronic presentations should be submitted to the liaison department to enable screening for compatibility and viruses. Contact the liaison department to ascertain when the material should be submitted. Written materials should be submitted to the liaison department to allow the City to copy such materials. Contact the liaison department to ascertain when the material should be submitted. Any written materials submitted during the meeting should include sufficient copies for the Board, Commissions or Committee and the public.

2. Consent Calendar

A. Senior Advisory Commission Minutes of May 21, 2018 On a motion by Commissioner Seeger, and a second by Commissioner Toledo, the Commission approved the minutes for the regular meeting.

- i. Aye (5) Commissioners Estrada, Garcia, McCauley, Seeger, and Toledo.
- ii. Excused (1) Commissioner Orme.
- iii. Abstain (1) Commissioner Buck.

3. Public Presentations

A. Ken Sinclair expressed the need for additional street corner curb cuts in residential areas.

4. General Business

- A. Senior Advisory Commission 2017-18 Work Plan & Goals update
 - i. Develop opportunities to promote Health and Wellness

- Host "Be Strong, Live Long" Health & Wellness Fair May 2018 (Commissioner McCauley) – Commissioners reported continued positive feedback from the event.
- Promote "Brain Health" through research article, and events Commissioner Buck commented on the importance of mindfulness.
- ii. Promote Elder Fraud Workshops Quarterly (Commissioners Estrada/Garcia) Commissioners commented on the wonderful presentation by the City's IT Department. There were 40 plus people in attendance, and the information was helpful, timely, and applicable. The Commission is interested in a follow-up presentation including actual use of the Computer Lab at the Senior Center.
- iii. Champion implementation of the World Health Organization's "Age-Friendly City Initiative" in Santa Clara (All) – Recreation Manager Castro informed the Commission that staff are finishing the Senior Needs Assessment report. The Commission inquired about signage to indicate the City's Age-Friendly designation, and suggested additional publicity to inform the community about becoming an Age-Friendly City.
- iv. Send two (2) representatives to attend the City's ADA Committee meetings (Commissioner Orme and Toledo) – Commissioner Toledo reported that the June meeting was canceled. Council Member O'Neill reported that the City Manager's Office is looking to improve Committee efficiency.
- B. Senior Advisory Commission Election of Chair and Vice Chair Commissioner Buck nominated Commissioner Estrada for Chair, seconded by Commissioner Seeger. Commissioner Toledo nominated Commissioner McCauley for Chair, seconded by Commissioner Garcia. The vote was split three (3) in favor of Commissioner Estrada and three (3) in favor of Commissioner McCauley. Commissioner McCauley declined nomination, and Commissioner Estrada was elected as Chair. Commissioner Toledo nominated Commission McCauley for Vice Chair, seconded by Commissioner Seeger. The Commission voted 6-0 in favor of Commissioner McCauley as Vice Chair.
- C. Senior Advisory Commission 2018-19 Work Plan & Goals The Commission reviewed the 2017-18 Work Plan & Goals and offered potential goals for the 2018-19 year using the eight (8) domains of the Age-Friendly City guidelines. The Commission expressed interest in continuing: support Health and Wellness by sponsoring the annual "Be Strong, Live Long Health & Wellness Fair," support and advocacy for the "sandwich generation," promotion of Elder Fraud Prevention Workshops, implementation of the Senior Needs Assessment findings, and participation in the City's Pedestrian Master Plan.

Senior Advisory Commission draft 2018-19 Work Plan & Goals

BACKGROUND

At the June 25, 2017 Senior Advisory Commission meeting, the Commission brainstormed projects and activities for the 2018-19 Work Plan. The draft plan was created through discussion of current trends relating to the senior population. The following goals are of interest based on priority and community needs:

- Promote Quarterly Elder Fraud Prevention Workshops

- Send two (2) representatives to attend the Pedestrian Master Plan Committee
