We felt we could better understand the process and could help more businesses if we underwent the certification process and became certified ourselves.

systems we have, what type of paper and cleaning products were being used, what type of the water pressure was, etc. Once we gathered this information, we made sure our supplies and appliances met the Green Businesses certification requirements.

Some existing efforts included: 1) Having garbage and recycling bins at every desk. Each break room has additional food scraps containers to collect food scraps; 2) Collecting food scraps for recycling 3) Collecting hazardous waste like paint and batteries for proper disposal: 4) The shared use of a hybrid vehicle.

New measures included: 1) Installing motion sensors to ensure lighting was only on

when rooms were occupied; 2) Updated the City's cleaning other city divisions to find out products to use only non-toxic green certified products.

> The Environmental Programs Division plans to move forward by helping get other city facilities certified and aiding other business through the process. Certifying the Corporation Yard allowed us to understand the effort that is needed to complete the checklist so that we can have a better understanding of the process and challenges.

Getting our office certified has increased the morale of our staff. It also provided an opportunity for education and awareness of why we implemented new measures.

For other business that are considering certification, know that this certification lets the community know you are doing what you can to create a better more sustainable community.

# **Green Business Tips: How to Prevent Illegal Dumping**

It is an unfortunate reality that illegal dumping occurs in commercial and industrial areas. Here are some things you can do to discourage this activity:

- Store all garbage, recycling and organic waste in a designated enclosure. Well lit enclosures discourage illegal dumping.
- 2. Keep container lids and enclosure doors closed. Increase service if there is overflow. If you'd like to install a lock on your containers, contact your hauler.
- 3. Keep property tidy—maintain

- your landscaping, remove litter and clean-up graffiti immediately. To report graffiti, call the Department of Public Works at 408-615-3080.
- 4. In some extreme cases, a security guard or surveillance cameras can deter illegal dumpers.

If you witness illegal dumping in progress, call the Santa Clara Police Department at 408-615-5580. Be prepared to give a vehicle description (license plate, make, color, etc.). If possible, take photos as long as you can do so in a safe manner.
