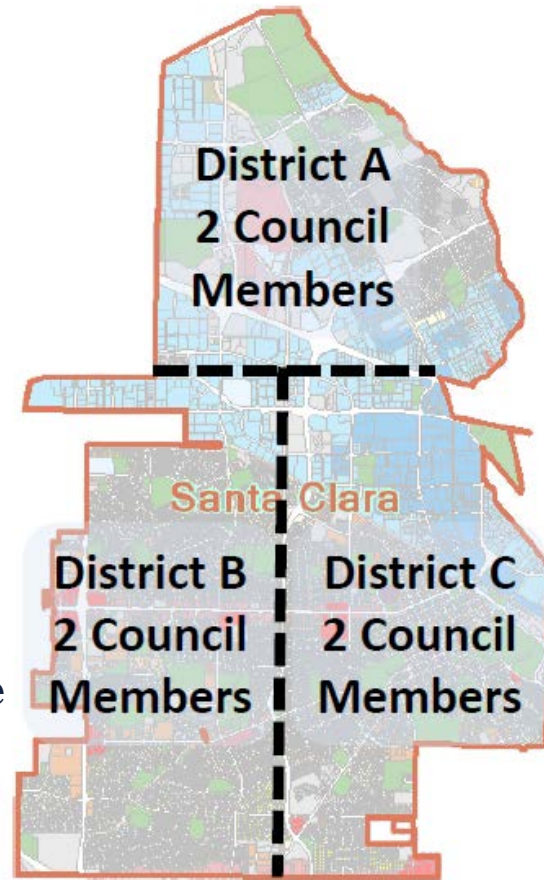

3 Districts

3 / 3 Option

- **Gubernatorial**
 - District A elects 1 councilmember
 - District B elects 1 councilmember
 - District C elects 1 councilmember
 - Mayor elected City-wide
- **Presidential**
 - District A elects 1 councilmember
 - District B elects 1 councilmember
 - District C elects 1 councilmember
 - City Clerk & Police Chief elected City-wide
- All voters get to vote in every election
- No unfair imbalance of voter turnout



2 / 4 Option

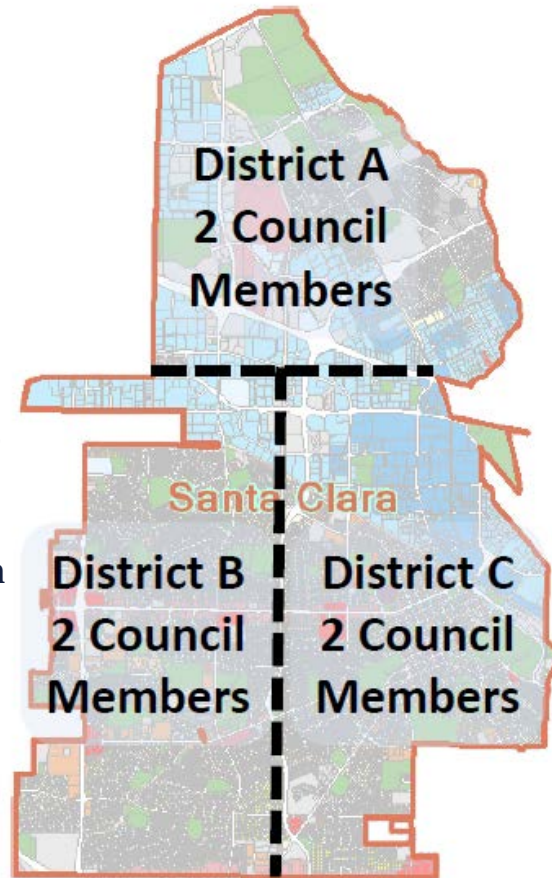
- **Gubernatorial**
 - District A elects 2 councilmembers
 - District B elects 0 councilmembers
 - District C elects 0 councilmembers
 - Mayor elected City-wide
- **Presidential**
 - District A elects 0 councilmembers
 - District B elects 2 councilmembers
 - District C elects 2 councilmembers
 - City Clerk & Police Chief elected City-wide
- Not all voters get to vote for councilmembers in every election
- Voter turnout imbalance of gubernatorial vs presidential elections
- Depending on the election method the winning threshold to guarantee a CM of your choice is lower.



3 Districts – transition plan

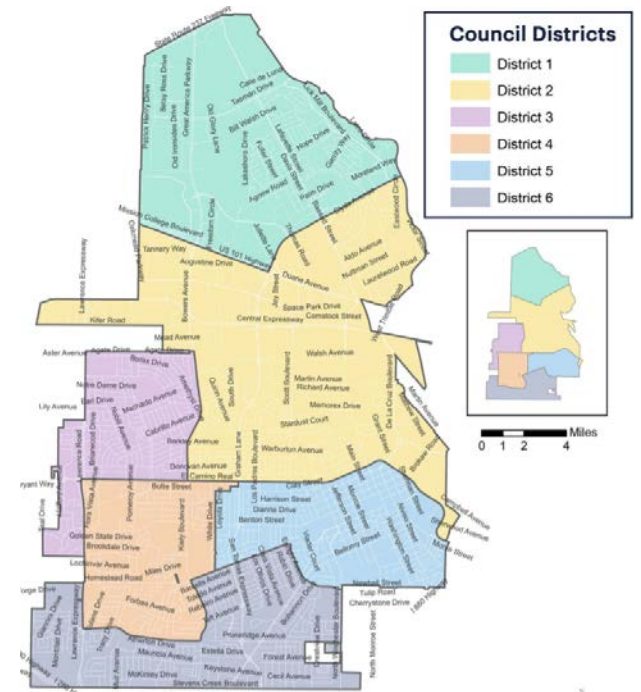
3 / 3 Option

- November 2020:
 - 4 seats are up for election
 - The 2 seats in districts that encompassed the 2018 Districts 2 and 3 elect 1 councilmember each for a standard 4 year term
 - The district that is not represented by 2018 Districts 2 or 3 elects 1 councilmember for a standard 4 year term, and 1 councilmember for a shortened 2 year term
- November 2022:
 - 2 districts from 2018 are up for re-election
 - 1 district that had a shortened 2 year term is up for re-election



2 / 4 Option

- Complex transition plan due to Districts 2 and 3 having been elected in 2018, yet they are not geographically contiguous districts, so they cannot be “merged” as a single district.

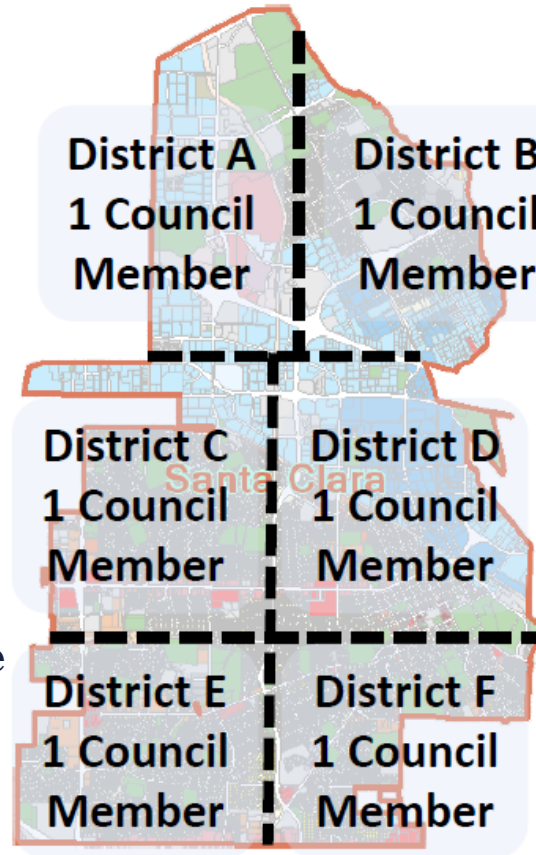




6 Districts

3 / 3 Option

- **Gubernatorial**

2 / 4 Option (Court Order)

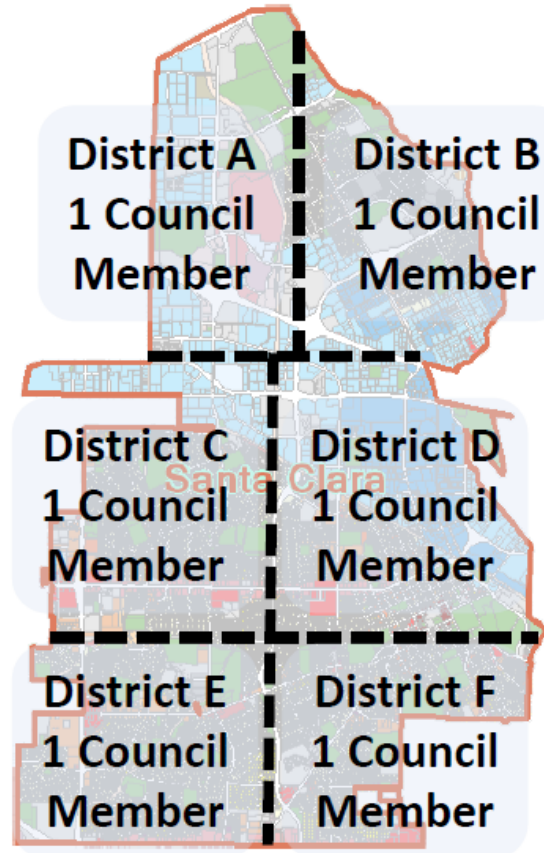
- **Gubernatorial**

6 Districts – transition plan

3 / 3 Option

- November 2020:
 - 4 districts are up for election
 - 3 of the districts: standard 4 year term
 - 1 of the districts: shortened 2 year term
- November 2022:
 - 2 districts from 2018 are up for re-election
 - 1 district that had a shortened 2 year term is up for re-election



2 / 4 Option (Court Order)

- No transition plan needed



Residency Requirements

- **What if a sitting councilmember, during their term:**
 - Moves out of the City?
 - Moves out of the district for which they were elected, but remain within the City?
 - Is redistricted out of the district for which they were originally elected?



Redistricting Committee

- Who appoints?
- What is the size of the committee?
- How long do they serve for?
- Any requirements about not running for office? For what duration? Does it apply to City-wide offices?
- Any requirements about not being an officer for any candidate? For what duration? Does it apply to City-wide offices?
