#### **Neighborhood Unit Updates**

- Changes For The 2020-2021 Academic Year
  - Residents shall refrain from placing tables or any type of furniture or items on the front lawn of the Neighborhood Unit, including beer pong tables.
  - Drinking games or simulated drinking games (i.e., water pong) are strictly prohibited in exposed porches, balconies, and common outdoor areas.
  - Sanctions and or fines have shifted to the following:
    - A fine of \$500.00 for the first offense
    - Any additional violations will result in a violation of the Student Conduct Code.
       Sanctions for these violations could include but are not limited to, Housing Contract Probation, Housing Contract Cancellation (\$1000.00 cancellation fee), Disciplinary Probation and additional fines.
