



Winter 2021 Campus Updates

- SCU winter quarter (January 2021-March 2021) a limited number of in-person undergraduate classes and limited-capacity on-campus housing for students
 - A limited number of classes to be offered in person or hybrid
 - All classes will be taught online for the first two weeks of the quarter. The limited number of in-person classes will begin January 19.
- Student Housing
 - On-campus housing for up to approximately 1,500 undergraduate students
 - Single-occupancy housing accommodations in residence halls and University Villas
 - Neighborhood Units will not be occupied for Winter nor Spring Quarter





Testing on Campus

- SCU will host required weekly testing of all on-campus students as well as off-campus students who use campus facilities such as classrooms, the library, labs, etc. Students who live off-campus who don't have hybrid classes are encouraged to come to weekly testing.
- In addition, everyone's adherence to the Bronco Pact will be critical to ensuring everyone's safety. This commitment includes mandatory symptom checks, participation in contact tracing and tracking (10 full-time trained contact tracers), and reporting of positive cases (even those without symptoms), to 408-554-5100.

Bronco Pact

- All members of our community play a role in creating a safer campus for fellow students, faculty, and staff, whether by being remote or following the health and safety protocols when on-campus. The actions described below will be mandatory and monitored, with violators subject to sanctions.
 - As a Bronco, I pledge to follow the state, county, and University guidelines by:
 - Wearing face coverings at all times on campus—indoors and outdoors
 - Practicing social distancing (6-feet minimum) at all times—indoors and outdoors
 - Staying at home if I am sick or experiencing any [COVID-19 symptoms](#)
 - Getting tested when I come into contact with someone who tests positive or if I am experiencing symptoms
 - Regularly disinfecting shared/common areas and items
 - Following Santa Clara County isolation protocols if I come into contact with someone who tested positive or when feeling ill
 - Participating in SCU's COVID-19 contact tracing program through the [symptom checker](#)
 - Washing or sanitizing hands frequently throughout the day
 - Practicing good cough and sneeze hygiene
 - Establishing a plan for where I will isolate if I test positive
 - Engaging in a conversation with my housemates or roommates about behavioral expectations, such as social behavior and living arrangement cleanliness
 - Complying with our collective commitment to safety efforts during this pandemic will clear a path to reopening campus. Likewise, failing to comply is a serious violation of the Student Conduct Code. The Student Conduct Code and disciplinary action applies to all students whether on or off campus. Students who are cited for failing to abide by campus, county and state health and safety protocols are subject to the full range of disciplinary actions.

INTRODUCTION

To reduce the spread of the virus in our community, we have put in place a number of health and safety protocols, as recommended by our health experts and medical authorities in our county and state.

These protocols are part of the 'Community of Care' pact, our commitment to each other to all do our part in stopping the spread of the virus.

ALL STUDENTS ARE EXPECTED TO:

Report positive COVID-19 test results at 408-554-5100, regardless of location.

Complete Daily Symptom Tracker

Not come to campus if you are sick or experiencing any COVID-19 symptoms

Participate in SCU's COVID-19 contact tracing program

Wear face coverings at all times on campus—indoors and outdoors

Practice social distancing (6-foot minimum) at all times—indoors and outdoors

Wash or sanitize hands frequently throughout the day

Practice good cough and sneeze hygiene

Students who received waivers to live in on-campus housing will not be permitted to enter other residence halls, host any guests, or use many communal facilities.



Failing to comply with our collective commitment to safety efforts during this pandemic is a serious violation of the Student Conduct Code. Students who are cited for failing to abide by campus, county and state health and safety protocols are subject to the full range of disciplinary actions including fines, restricted access to campus facilities, disciplinary probation, deferred suspension, suspension, and expulsion. The Student Conduct Code and its full range of disciplinary actions applies to all students whether on or off campus.

- **Information included in weekly email updates to all students:**
 - **Important Information for Off-campus Students:** As we mentioned previously, the County Health Officer's order remain in effect. Unfortunately, some off-campus student residents have not been complying with these public health rules and were recently issued citations by the Santa Clara Police Department. The County's order prohibits hosting or attending any gatherings, regardless of size. **The consequences of throwing parties or hosting gatherings are significant and can include citations and fines from both the police and Santa Clara University, in the case of SCU-owned off-campus housing. Santa Clara PD will continue to enforce and respond to complaints.**
