



# POLICE BLOTTER

Week of October 11, 2020



The Police Blotter highlights a partial list of incidents in the city and is distributed on a weekly basis. The Blotter provides the date, time, approximate location, a narrative summary of the incident, case number and the most serious arrest charge.

Meanwhile, the Arrest Log provides a timely, chronological summary of all the arrests made by the Santa Clara Police Department. It includes the name of the suspect(s), date of birth, city in which they reside, arrest date, time, location, case number as well as all the charge(s) associated with the arrest. This information, located on the Santa Clara Police Department's home page (<a href="www.scpd.org">www.scpd.org</a>), is updated daily and serves as the most comprehensive list of arrests made.

Based on the mandatory orders from Santa Clara County Public Health, the City of Santa Clara has implemented many service level changes, limited to essential services. Since the preparation and distribution of a Police Blotter is not an essential service, it will be produced as resources are available.

## Sunday, October 11, 2020

Prowler Location: 400 Block of Washington Street
Public Safety Dispatchers received a call for service regarding a male subject acting suspicious and trespassing on a property on the 400 block of Washington Street.

On arrival, officers located a male subject matching the reporting party's description. The officer immediately noticed the subject's shorts had a large hole exposing his genitals. The subject indicated he was charging his phone. He was issued a warning for trespassing and told to leave the premises.

Approximately thirty minutes later, Public Safety Dispatchers received a follow-up phone call. The male had returned. The condition of his clothing had worsened, he was observed peeking through the window of the residence and screaming obscenities to the residents. Officers returned and arrested the male, who was subsequently transported to the Santa Clara County Jail.

### Monday, October 12, 2020

Attempted Murder Location: El Camino Real and Jackson Street
An officer on routine patrol observed a vehicle traveling at a high rate of speed on Lafayette Street
near El Camino Real. Almost simultaneously, the officer observed a vehicle flashing its' headlights on

and off as the vehicle traveled in an aggressive manner toward the officer. It was obvious the driver was desperately trying to get the officer's attention.

The male driver indicated someone was shooting at him, provided a vehicle description and direction of travel. The officer initiated a high-risk traffic enforcement stop. The vehicle was occupied by five subjects.

After pulling over, the driver immediately exited the vehicle and began to walk away from the vehicle. The officer provided verbal commands and the subject became argumentative. The balance of the subjects remained in the vehicle. All of the subjects were detained in handcuffs while officers conducted their investigation.

A search of the vehicle yielded a loaded firearm. Four shell casings were located in the area of the shooting, near Scott Boulevard and Monroe Street. The casings matched that of the firearm located in the vehicle. All of the vehicle's occupants were transported to the Police Department to be interviewed. Through investigation, it was determined the passenger in the front seat conducted the shooting. He was arrested and transported to the Santa Clara County Jail.

The firearm was not registered to any of the vehicle's occupants however it has not been reported stolen. There were several bullet holes in the victim's vehicle.

The subject(s) fled the scene with the stolen property and have not been identified. The total loss is estimated at approximately \$140,000 in damages and stolen property.

Public Safety Dispatchers received a call for service regarding a physical fight on the 1000 block of Kiely Boulevard.

On arrival, officers located three male subjects matching the reporting party's description. The subjects displayed objective symptoms of alcohol intoxication. Despite evidence of a physical altercation, the subjects denied a fight had occurred.

One of the subjects was unable to care for himself due to his level of alcohol intoxication. He was arrested and booked into the Santa Clara County Jail.

Drugs for Sale Location: Central Expressway and De La Cruz Boulevard An officer was patrolling the area of Central Expressway and De La Cruz Boulevard when a vehicle was observed with expired registration. The officer initiated a traffic enforcement stop. The vehicle was occupied by two male subjects.

On contact, the officer conducted a Records check. It revealed the driver of the vehicle was on searchable probation. A search of the vehicle revealed a controlled substance in an amount inconsistent with personal use and supplies consistent with drug sales. The subject was transported to the Santa Clara Police Department's temporary holding facility for processing and was release on his own recognizance.
