# Santa Clara Stadium Authority to Consider Removing Forty Niners' Ability to Execute Contracts for Non-NFL Operations at Levi's® Stadium

The Forty Niners - as the Stadium Manager - may soon have to get Stadium Authority's approval for all contracts, if ordinance is amended

**SANTA CLARA, Calif.** – During the Tuesday, Sept. 17 special meeting that runs concurrently with the City Council meeting, the Santa Clara Stadium Authority Board (Board) will consider amending an ordinance to remove the Stadium Authority Executive Director's authority to execute contracts for non-National Football League (NFL) operations at Levi's® Stadium.

Currently, the Executive Director has delegated that authority to the Forty Niners Stadium Management Company, LLC (Forty Niners). As a result, the Forty Niners can execute contracts up to \$250,000 without seeking Board approval.

If the Ordinance is amended by the Board, all future stadium contracts on behalf of the Stadium Authority will require Board approval.

### Background

Despite the Stadium Manager's claim to have "substantial experience and expertise" in managing and operating public facilities, the Forty Niners have grossly mismanaged their procurement authority, violated state laws, and refused to produce the Stadium Authority's own contracts and documents to assess the extent of violations.

Per the Stadium Management Agreement, the Forty Niners provide management services for the stadium, including overseeing the day-to-day operations and maintenance of the stadium as well as the marketing and booking of non-NFL events.

The Forty Niners have incurred ongoing contracting violations, including state prevailing wage violations. Two Notices of Breach and Defaults were issued in 2019, along with the commencement of a forensic audit of the Stadium Manager's delegated procurement authority. The Forty Niners did not cure or resolve the breaches and defaults.

The Forty Niners have also refused to provide information and documents regarding the Forty Niners' actions on behalf of the Stadium Authority, including information regarding charged shared stadium expenses. The Stadium Authority cannot risk any further violations of law or liability based on the Forty Niners' failures to properly procure contracts and lack of transparency with the Stadium Authority.

# **Potential Next Steps**

If the Board moves forward with the removal of this delegated procurement authority as part of this first reading of the ordinance, the second reading would take place on Tuesday, Oct. 8. If the Board votes to adopt the ordinance at the October meeting, it would become effective 30 days later on Nov. 8, 2019.

# **About Tuesday's Meeting**

The City Council/Stadium Authority Board will go into closed session at 4 p.m. on Tuesday, Sept. 17, followed by a regular Council meeting and Stadium Authority special meeting, beginning at 5:15 p.m.
