## **STAFF REPORT**

**Recreation Manager Castro** provided an update on Parks & Recreation programs, parks projects and upcoming virtual park dedications. She mentioned that Santa Clara County is in the purple tier and in person recreation classes are starting in late February. She discussed the Food for Families program through the Salvation Army and the Senior Nutrition Program. She mentioned a Senior Health and Wellness Virtual Fair scheduled for May.

**COMMISSIONERS REPORT**

**Commissioner Sulcer** reported that she is working with an independent movie director that is planning to use the Swim and Recreation Club that she is a member of, to shoot an upcoming movie in March/April. She stated she enjoys being able to support this project during these times, and would like to share some information regarding the project with the public.

**Commissioner von Huene** attended a Behavioral Health Resources during Covid-19 Supplemental training, through CAP (COVID Ambassador Program). The training included behavioral health resources, an extensive list of phone numbers/help lines and various ways the City is supporting people who are affected during these times. The slides from the training are available to the public. Ambassadors receive information and are asked to share accurate information with friends, family and the community.

**Chair Samara** also attended the CAP (Covid Ambassador Program) training. He mentioned the pandemic has increased the need for mental health resources to be available to the community.

The time limit within which to commence any lawsuit or legal challenge to any quasi-adjudicative decision made by the City is governed by Section 1094.6 of the Code of Civil Procedure, unless a shorter limitation period is specified by any other provision. Under Section 1094.6, any lawsuit or legal challenge to any quasi-adjudicative decision made by the City must be filed no later than the 90th day following the date on which such decision becomes final. Any lawsuit or legal challenge, which is not filed within that 90-day period, will be barred. If a person wishes to challenge the nature of the above section in court, they may be limited to raising only those issues they or someone else raised at the meeting described in this notice, or in written correspondence delivered to the City of Santa Clara, at or prior to the meeting. In addition, judicial challenge may be limited or barred where the interested party has not sought and exhausted all available administrative remedies.

If a member of the public submits a speaker card for any agenda items, their name will appear in the Minutes. If no speaker card is submitted, the Minutes will reflect "Public Speaker."

In accordance with the requirements of Title II of the Americans with Disabilities Act of 1990 ("ADA"), the City of Santa Clara will not discriminate against qualified individuals with disabilities on the basis of disability in its services, programs, or activities, and will ensure that all existing facilities will be made accessible to the maximum extent feasible. The City of Santa Clara will generally, upon request, provide appropriate aids and services leading to effective communication for qualified persons with disabilities including those with speech, hearing, or vision impairments so they can participate equally in the City's programs, services, and activities. The City of Santa Clara will make all reasonable modifications to policies and programs to ensure that people with disabilities have an equal opportunity to enjoy all of its programs, services, and activities.
