



# **POLICE BLOTTER**

Week of April 11, 2021



The Police Blotter highlights a partial list of incidents in the city and is distributed on a weekly basis. The Blotter provides the date, time, approximate location, a narrative summary of the incident, case number and the most serious arrest charge.

Meanwhile, the Arrest Log provides a timely, chronological summary of all the arrests made by the Santa Clara Police Department. It includes the name of the suspect(s), date of birth, city in which they reside, arrest date, time, location, case number as well as all the charge(s) associated with the arrest. This information, located on the Santa Clara Police Department's home page (<a href="www.scpd.org">www.scpd.org</a>), is updated daily and serves as the most comprehensive list of arrests made.

Based on the mandatory orders from Santa Clara County Public Health, the City of Santa Clara has implemented many service level changes, limited to essential services. Since the preparation and distribution of a Police Blotter is not an essential service, it will be produced as resources are available.

## **Sunday, April 11, 2021**

Commercial Burglary Location: 2400 Block of Condensa Street
Public Safety Dispatchers received a call for service on the 2400 block of Condensa Street on the report of a prior theft.

Two male subjects cut the locking mechanism on a storage container and stole several construction tools from inside the container. The subjects were confronted and fled the scene in a vehicle. The estimated value of the stolen property is \$3,400. The subjects have not been identified and are still at large.

#### Monday, April 12, 2021

Embezzlement Location: 1000 Block of Walsh Avenue

A subject rented two vehicles from a business on 3/17/21 and did not return the vehicle as scheduled on 3/24/21. The business contacted the bank used to rent the vehicle to inform them of the incident and attempted to get a copy of the identification of the subject and/or surveillance footage of the subject without success.

One of the vehicles were recovered in Orange County (Case Number 21-408036). The second vehicle remains outstanding.

Prowling Location: 2400 Block of Karen Drive

At approximately 1818 hours, an officer was dispatched to the 2400 block of Karen Drive on the report of a suspicious male looking into vehicles and trying to open an apartment door.

On police arrival, witnesses pointed out the subject. The subject was attempting to exit the apartment complex. The subject was located, initially displayed paranoid, manic behavior, and became defensive and belligerent during the contact. He was arrested for prowling and transported to the Santa Clara County Jail.

### Wednesday, April 14, 2021

Fraud Location: 1900 Block of Don Avenue

A resident on the 1900 block of Don Avenue received a phone call from a person who identified themselves as a Social Security Administration agent. The subject stated the victim's social security number was associated with fraudulent changes and instructed the victim to purchase \$2,000 worth of gift cards. The victim complied with the request and called the subject back to provide the numbers on the gift cards.

The victim was then instructed to purchase another \$1,000 in gift cards. On this instance, the victim was instructed to contact the subject from the store parking lot, scratch the numbers off the gift cards and read them to the subject immediately after the purchase.

After speaking with a friend, the victim learned about this type of scam and contacted Public Safety Dispatchers to report the incident. The subject is unknown and at large.

Officers were dispatched to a business on the 3500 block of Monroe Street on the report of a petty theft.

The store manager referenced two subjects that have been frequenting the store and stealing items. The subjects came into the store on 4/15/21, began browsing items and left the store without paying for approximately \$200 in merchandise.

Responding officers were able to locate one of the subject's matching the store manager's description. A Records check revealed the subject has a warrant for his arrest out of state; the

warrant is not extraditable from California. The subject was admonished, advised not to return to the business and released from the scene.
