What Officers Can Do

*Trespassing on private property – If a subject unlawfully trespasses on private property, officers will be dispatched to assess the situation. The property owner must desire prosecution for trespassing before officers take

prosecution for trespassing before officers take any type of enforcement action.

* Abandoned vehicles – Officers will mark tires and place a warning on the vehicle

- tires and place a warning on the vehicle regarding the violation. If the vehicle is not moved within 72 hours, the vehicle can be cited. If the vehicle is not moved within ten days, the vehicle can be towed.
- *Aggressive panhandling Officers can enforce aggressive panhandling (647(c) PC) for a subject who willfully & maliciously obstructs the free movement of any person in any public place) if the victim wants prosecution.
- * Community Response Team can assist, guide, and refer unhoused subjects to service providers

What Officers Can't Do

- * Camping on public property/RV parking Federal courts ruled that cities cannot prosecute individuals as an unavoidable consequence of being homeless (unless alternative shelter is available). This includes sleeping/living in a vehicle, motorhome, trailer, or on public land.
- * **Panhandling** Asking for money is not illegal and is protected under the 1st amendment.
- * Camping or sleeping in creeks/railways/bus stops The creeks, railways, and bus stops in Santa Clara are privately owned by the Santa Clara Valley Water District, Union Pacific Railway, or VTA. The property owner must request enforcement action for trespassing prior to any law enforcement action.

What You Can Do

- * If there's an emergency please dial 9-1-1.
- * If there is not an emergency please call **408-615-5580** to report illegal activities.
- * Encampments (private property) –
 If you notice an encampment on private
 property (i.e. private parking lot, construction
 site, embankment or railways) and you're not the
 property owner, please contact the Santa Clara
 Police Department Community Response Team
 (CRT) 408-615-4745. The CRT will locate

the property owner and inform them of the encampment.

*Encampments (government property) –
If you notice an encampment on property owned by other government agencies (i.e. creek, school, freeway or bus stop), please contact the

* **Property owners** – There are several things you can do to deter encampments;

- Post signage on your property forbidding and prosecuting trespassing
- Keep property well lit and secure
- Keep property clean of debris
- Avoid overgrown foliage
- Contact CRT for advice and to enforce trespass laws
