



POLICE BLOTTER
Week of July 11, 2021



The Police Blotter highlights a partial list of incidents in the city and is distributed on a weekly basis. The Blotter provides the date, time, approximate location, a narrative summary of the incident, case number and the most serious arrest charge.

Meanwhile, the Arrest Log provides a timely, chronological summary of all the arrests made by the Santa Clara Police Department. It includes the name of the suspect(s), date of birth, city in which they reside, arrest date, time, location, case number as well as all the charge(s) associated with the arrest. This information, located on the Santa Clara Police Department's home page (www.scpd.org), is updated daily and serves as the most comprehensive list of arrests made.

Based on the mandatory orders from Santa Clara County Public Health, the City of Santa Clara has implemented many service level changes, limited to essential services. Since the preparation and distribution of a Police Blotter is not an essential service, it will be produced as resources are available.

PRESS RELEASE - Burglary and Shooting

On Sunday, July 11, at about 1:49 am, Santa Clara officers responded to the 1000 block of Santa Clara Street on a report of a prowler. The reporting party said a male suspect was in the backyard of their home. As units responded to the call, they learned that gunshots had been fired.

The subsequent investigation revealed that the occupants of the home were awoken by the sounds of pounding and kicking on their doors and windows. The suspect broke a window at the front of the home. The suspect then forcibly kicked open a rear door, at which time the resident fired multiple shots at him. The gunshots immobilized the suspect. There are no known associations between the suspect and the residents.

The suspect is identified as Spencer Olson, a 26-year-old male resident of Los Gatos. He was arrested for burglary and transported to an area hospital for treatment.

The victim is only being identified as a 51-year-old male resident of Santa Clara. He has been cooperative with the investigation.

Driving Under the Influence Location: Central Expressway and Lafayette Street

Public Safety Dispatchers received a call requesting a welfare check of a person asleep in the driver's seat of their vehicle at Central Expressway and Lafayette Street.

On arrival, officers located the male subject in the driver's seat with the keys in the ignition, and the gear in the drive position. On contact, the subject displayed objective symptoms of alcohol intoxication, admitted to drinking alcohol, and agreed to a preliminary alcohol screening test. The subject refused to conduct the Standardized Field Sobriety Test and consented to a blood chemical test. The subject was arrested and transported to the Santa Clara County Jail.

An officer was deployed to the 500 block of Mansion Park Drive on the report of a male subject trespassing and harassing maintenance personnel.

The responding officer contacted the subject. A Records check revealed he has three active grants of probation all with search and seizure clauses. During a probation search, the officer located several items that are commonly used to commit burglary. The subject was issued a citation for burglary tools and admonished for trespassing.

Fraud

Location: 1900 Block of Fillmore Street

An officer responded to the 1900 block of Fillmore Street on the report of a fraud.

The victim was on military duty when a stimulus card containing \$1,400 was mailed. The victim received a letter from the United States Post Office that his mailbox was compromised in April 2021, and it was unknown what mail, if any, had been stolen.

The victim returned from military duty in May 2021 and discovered his stimulus card was in fact stolen. The victim contacted the Internal Revenue Service to request a replacement card. A replacement card was received on 7/15/21. When the victim called the phone number on the back of the card to check the balance, he discovered it was at \$0. The victim contacted law enforcement to document this instance of fraud.
