Free COVID-19 Testing & Get Vaccinated


In partnership with the County of Santa Clara, the City hosts free COVID-19 testing at Central Park Library, 2635 Homestead Ave. The next testing dates are Feb. 9 and 23, from 9:30 a.m. to 3 p.m. Typically, 3-7 days before the testing date, <u>schedule an appointment</u> online. Visit <u>SCCFreeTest.org</u> for countywide testing locations. Make an appointment for COVID-19 vaccinations and boosters at <u>SCCFreeVax.org</u> or <u>MyTurnCA.gov</u> for all those eligible.

The County of Santa Clara is Providing Free At-Home COVID-19 Antigen Tests

Those who live, work, or attend school in Santa Clara County can sign up online, then pick up tests from one of four distribution sites. Schedule to pick up your at-home COVID-19 antigen tests within Santa Clara County by visiting SCCFreeTest.org.

Residential and Business Alarm Permits

The City transitioned to a third party for management of the Residential and Business Alarm Permit program in January 2021. As a result, you may receive a letter on City of Santa Clara letterhead referencing establishing an online account at https://www.crywolfservices.com/santaclaraca/. This is legit! If you have received a letter, set up an account on the portal or call customer service at 877-665-2983. A summary of the City of Santa Clara's transition to a third-party vendor for management of this program is available online.

How and Where to Report Emergency and Non-Emergency Situations

While the Santa Clara Police Department are actively using Facebook, Instagram, Nextdoor, Nixle, and Twitter, staff are NOT monitoring these sites for emergencies. Instead, Public Safety Dispatchers work 24/7, 365 and have the ability to deploy police, fire or medical resources as necessary. Dial 9-1-1 in an emergency or 408-615-5580 for non-emergency situations.

2022 Santa Clara County Homeless Point-in-Time Count

The 2022 Santa Clara Point-in-Time Count is a count of all populations of person's experiencing homelessness. The Count is a requirement for receiving federal homeless assistance funds and provides critical data used to understand homelessness locally. The count is scheduled for Wednesday, Feb. 23 and Thursday, Feb. 24, 5 a.m. to 10 a.m. To register, visit: https://bit.ly/SantaClaraPIT2022.

It is a rare occasion, and an enormous honor, to represent the City of Santa Clara. Last month I attended the U.S. Conference of Mayors in Washington D.C. and was able to take part in a series of educative meetings and panel discussions on topics that are extremely relevant to the <u>City of Santa Clara</u>.

I was also fortunate to be able to listen to governmental leaders including President Joe Biden, Transportation Secretary Pete Buttigieg, and others, each providing updates on key matters including projected funding for infrastructure and community grant programs. Topics on the agenda included the Challenges of Pandemic, Public Safety including Reducing Gun Violence, Cybersecurity, Reducing Homelessness, Affordable Housing, Racial Equity, Metro Economies and Spurring Economic Growth, Micro-business Development, Water Conservation, American Rescue Plan Act, Infrastructure Investment and Jobs Act, Energy Efficiency, Transportation, and Veteran Services.

While in D.C., Santa Clara was far from the largest city in attendance at the United States Conference of Mayors, I was taken back by how many other mayors and governmental representatives were asking about our city's successes— everything from our utility

They also wanted to know how we are approaching transportation and infrastructure challenges, and more. There was plenty of collaboration and sharing of information.

City of Santa Clara Tasman Garage Closure

The City of Santa Clara Tasman garage, located at 2525 Tasman Dr., will be closed for routine maintenance Feb. 14 through Feb. 22. There will be no access to public EV charging

Shared Mobility Update (Bicycle and Scooter Share)

On Dec. 7, 2021, the City Council adopted an ordinance and draft regulations for a new Shared Mobility Program which will allow up to 1,000 bicycles and 2,000 scooters to be rented and used within the City. The period for prospective operators to submit applications to the City is from Feb. 1 to March 31. If selected, operators will be issued a permit to deploy bicycles and scooters throughout the City starting in July 2022. For more information, visit: SantaClaraCA.gov/SharedMobilityProgram.

New Composting Law

Beginning in 2022, a new recycling requirement for all Californians took effect. This new "composting law" requires every jurisdiction to provide organic waste collection services for all residents to reduce the



amount of organic waste sent to landfills. Organic waste includes food waste, vegetation, organic textiles, wood, and paper products. The decomposition of organic waste once it's in the landfill is a significant source of greenhouse gas emissions. The goal of this new regulation aims to reduce landfill methane emissions which will reduce the impacts of climate change. City of Santa Clara residents are already compliant with the law and no sorting or additional containers are required. For more information, visit SantaClaraCA.gov/CleanSC.

Extra Cardboard Curbside Collection Reminder

Cardboard should be broken down and folded before being placed inside the blue recycle cart with the lid closed. Extra cardboard that cannot fit inside the blue cart should be flattened & bundled with twine, string, or packaging tape into 4' by 4' sections. Place the bundled cardboard next to the recycling cart for collection on your service day. Neighborhood University Relations Committee

Independent Redistricting Commission

Redistricting occurs every 10 years after each U.S. Census. Santa Clara is required to consider an update to the boundaries of its six districts based on the 2020 U.S. Census data. The City's Independent Redistricting Commission is responsible for conducting the redistricting process. The Commission will adopt a new City Council District map no later than April 17, 2022 based on Census 2020. Upcoming Commission meetings are scheduled for **Thursday**, **Feb. 10**, **2022**, **at 6 p.m.** and **Monday**, **Feb. 28**, **2022**, **at 6 p.m.** At the meetings, the public may propose draft plans and provide input. 


Community Meeting for 275 Saratoga Avenue Senior/Assisted Living/Memory Care Project


The applicant, Swenson Builders, will be hosting a virtual community meeting on **Wednesday, March 2, 6 p.m.** to share their proposed rezoning at 275 Saratoga Avenue to construct a 166,892 square foot 4-story senior assisted living / memory care facility over a sub-grade parking garage with 73 parking spaces and site improvements. The Project includes demolition of the existing 30,050 square foot 2-story office building. City Staff will be in attendance to receive feedback provided on the proposal. Environmental Day is subject to all California Department of Public Health and Santa Clara County Public Health orders and guidelines. Stevens Creek Boulevard and Winchester Boulevard Pavement Rehabilitation and Bike Lanes Project

The City of Santa Clara and the City of San Jose are working on a joint project to rehabilitate pavement on Stevens Creek Boulevard between Stern Avenue and Interstate 880 and Winchester Boulevard between Newhall Street and Stevens Creek Boulevard. It is anticipated that the project will take place during summer of 2022. In addition to pavement work, both cities are considering the installation of new bike lanes on Stevens Creek Boulevard and Winchester Boulevard. Adding bike lanes on Winchester Boulevard would require the removal of on-street parking. In March 2022, the City of Santa Clara and the City of San Jose will host two community meetings to present the options for bike lanes along Winchester Boulevard, discuss parking removal and gather community input. Apply to Be a Crossing Guard

Crossing Guards play a vital role in community safety! Crossing Guards help children safely cross the street on their way to and from school. However, our well-trained colleagues are also present to:

- Discourage children from behaving in an unsafe manner near traffic, such as darting into the street without looking or crossing against a traffic signal;
- Encourage children to walk their bicycle or scooter in crosswalks;
- Use existing gaps in traffic to help students cross safely. When the natural traffic flow does not allow enough time for children to safely cross a street, a Crossing Guard may create gaps by stopping traffic temporarily;
- Alert motorists that pedestrians of unsafe traffic safety behaviors; and,
- Observe and report any incidents or conditions that present a potential safety hazard.

Crossing Guards generally work approximately 10-15 hours per week in an as-needed, non-benefitted capacity. Applicants must have a valid California driver's license and be at least 21 years of age. Hours and locations vary. The rate of pay is \$16.40 - \$17.21 per hour. An application is available at www.SantaClaraCA.gov/HR.
