Why AB 481

- September 30, 2021 Gov. Newsom signed 8 police reform bills, including AB 481
- Increase transparency, accountability, oversight for acquisition and use of equipment
- Provide safeguards to protect public's welfare, safety, civil rights and liberties
- Requires an annual report to summarize
 - equipment usage and updates
 - document internal audits
 - summarize community feedback
- Create public forum for input and engagement



AB 481 Requires Initial Approval and Annual Reporting

- AB 481 requires approval for continued use of item purchased prior to January 1, 2022
- It also requires an annual report; SCPD's first annual report is planned for May 2023
- Annual report to include:
 - how equipment is being used
 - maintenance and use costs
 - internal audits
 - community feedback on use



Why do we need this equipment?

Goal:

Safe, peaceful resolution for the involved parties, the public and officers

Concerns:

Actions, capabilities and intentions

Factors that influence sound decisions:

Time, distance and cover



Critical Incidents in Santa Clara County

Date	Incident	Brief Summary of Incident	
7/28/19	Gilroy Garlic Festival	Gunman killed 3 people and wounded 17	
May - June, 2020	County-wide protests in response to George Floyd murder	Riots, fires and looting ensued, resulting in a community-wide curfew. Officers were injured after being hit with objects thrown at them during protests	
8/5/20	Santa Clara County Main Jail	Gunman restrained in handcuffs fired several rounds at officers in Main Jail sallyport. Containment took 4 hours *	
8/9/20	Santa Clara County Main Jail	Driver slammed through Main Jail security gate and refused to surrender *	
5/26/21	VTA Railyard Shooting	9 people killed	
November – December, 2021	Retailer break-ins	Organized groups of 15-30 people breaching retail stores to steal high end merchandise	

^{*} At the times of these incidents, SCPD had officers in the jail booking area with their own arrestees



How Equipment Can Be Funded

- City of Santa Clara General Fund
- City of Santa Clara Capital Improvement Project
- Asset Forfeiture Funding
- Local, State and Federal Grants
- Reallocation of City Resources
- Transfer of Department of Defense property to Law Enforcement Agencies (obtained through the 1208 or 1033 Programs) *

^{*} SCPD has NOT sought out or received the transfer of Department of Defense equipment through the 1208 or 1033 Programs



Equipment Categories per AB 481

- Unmanned, remotely piloted, powered aerial or ground vehicles (Category 1)
- Mine-resistant ambush-protected vehicles or armored personnel carriers (Category 2)
- High mobility multipurpose wheeled vehicles (HMMWV), two-and-one-half-ton trucks, five-ton trucks, or wheeled vehicles that have a breaching or entry apparatus attached (Category 3)
- Tracked armored vehicles that provide ballistic protection to their occupants (Category 4)
- Command and control vehicles that are either built or modified to facilitate the operational control and direction of public safety units (Category 5)
- Weaponized aircraft, vessels, or vehicles of any kind (Category 6)
- Battering rams, slugs, and breaching apparatuses that are explosive in nature (Category 7)
- Firearms of .50 caliber or greater (Category 8)
- Ammunition of .50 caliber or greater (Category 9)
- Specialized firearms and ammunition of less than .50 caliber (Category 10)
- Any firearm or firearm accessory that is designed to launch explosive projectiles (Category 11)
- Noise-flash diversionary devices and explosive breaching tools, munitions containing tear gas or OC, excluding standard, service-issued handheld pepper spray
 (Category 12)
- TASER® Shockwave, microwave weapons, water cannons, and long-range acoustic devices (Category 13)
- Kinetic energy weapons and munitions (Category 14)
- Any other equipment as determined by a governing body or a state agency to require additional oversight (Category 15)

NOTE: SCPD is in possession of item(s) that meet the criteria for the highlighted categories

How Does this Affect Santa Clara?

- With City Council approval of Lexipol Policy 706:
 - SCPD will continue to have access to each of the resources currently available. In addition, the corresponding
 policies and procedures would remain in effect
 - Staff will be required to implement a tracking system for equipment use in preparation for the AB 481 Annual
 Report; this is an increase to existing workload
- Without City Council approval of Lexipol Policy 706:
 - The Department will cease the use of equipment designated by AB 481 as this equipment on April 30, 2022
 - The Department will be required to redesign our policies, procedures and operations for critical incident response; this includes our ability to provide and receive mutual aid
 - Public safety will be negatively impacted
