# **STAFF REPORT**

**Deputy Director Seale** provided the staff report for Parks Division. The Raymond G. Gamma Dog Park shelters are scheduled to be completed by the contractor in another week. Park projects moving forward with construction projected to start in fall 2022 include the Gazebo Project (City Plaza Park), Montague Park Rehabilitation Project and the Fairway Glen Restroom Project. The Department continues to move forward with the Public Works Design Division with the review of plans for the Magical Bridge All-inclusive Playground in Central Park.

**Manager Castro** provided the staff report for the Recreation Division. Winter programs had a rolling start from the beginning of the year with registrations. A few registrants cancelled due to coronavirus related illness. Also, staff continue to cope with the negative impacts of the pandemic. The Division is planning spring and summer programs now, so look for those to open within the next few months. The Senior Center has pick-up only food service due to the highly contagious omicron variant. All other program sites are fully operational as planned.

**Director Teixeira** provided the staff report for the Cemetery Division. He informed the Commission about the newly installed decorative fence on the seat wall at Mission City Memorial Park. The site has experienced vandalism and other negative impacts over the years and is now more secure with the new installation.

# **COMMISSIONERS REPORT**

**Chair Forte**: Attended the Holiday Tree Lighting event and visited Parkway Park.

Commissioner Hai: Visited Westwood Oaks Park.

**Commissioner Gonzalez**: Henry Schmidt Park is becoming an off leash area where park patrons are letting their dogs run off leash daily after 6:00 PM. She has questions and concerns regarding public access to the basketball courts, Townsend Field and Elmer Johnson Field at Buchser MS during after-school hours. **Director Teixeira** provided additional information and context on this topic.

**Commissioner Knaack**: Attended the Holiday Tree Lighting event. Wrapped up his final circuit of running to, and visiting all of the City parks, which concluded with Montague Park, Agnew Park, Agnews Historic Park, Fuller Street Park and Thamien Park.

**Commissioner Martinez**: Attended the Tree Lighting Event and visited Fremont Park.

**Vice-Chair Field**: Noted that Beautiful Day has availability for volunteer work in October 2022, and the Parks & Recreation Department may be able to benefit from this volunteer opportunity.

The time limit within which to commence any lawsuit or legal challenge to any quasi-adjudicative decision made by the City is governed by Section 1094.6 of the Code of Civil Procedure, unless a shorter limitation period is specified by any other provision. Under Section 1094.6, any lawsuit or legal challenge to any quasi-adjudicative decision made by the City must be filed no later than the 90th day following the date on which such decision becomes final. Any lawsuit or legal challenge, which is not filed within that 90-day period, will be barred. If a person wishes to challenge the nature of the above section in court, they may be limited to raising only those issues they or someone else raised at the meeting described in this notice, or in written correspondence delivered to the City of Santa Clara, at or prior to the meeting. In addition, judicial challenge may be limited or barred where the interested party has not sought and exhausted all available administrative remedies.

If a member of the public submits a speaker card for any agenda items, their name will appear in the Minutes. If no speaker card is submitted, the Minutes will reflect "Public Speaker."

In accordance with the requirements of Title II of the Americans with Disabilities Act of 1990 ("ADA"), the City of Santa Clara will not discriminate against qualified individuals with disabilities on the basis of disability in its services, programs, or activities, and will ensure that all existing facilities will be made accessible to the maximum extent feasible.
