Below Market Rate (BMR) Rental Program Orientation Webinar

Anyone interested in renting an affordable rental unit in Santa Clara should attend this free webinar! The [webinar](#) will be held on **Tuesday, April 5, 6 p.m.** Learn how to obtain an application ID, the application process, eligibility requirements and how to apply for future opportunity drawings. The orientation will be presented by HouseKeys, Inc., the City's Affordable Housing Program administrator.

Independent Redistricting Commission Adopts New Map

Every 10 years, cities must redistrict (adjust Council District boundaries to equalize total populations) using the new Census counts. Federal and state laws apply to this process and Cities must adopt new boundaries before April 17, 2022, these new council districts will be used until Census 2030 data are released. At the July 6, 2021 City Council meeting, the City Council adopted a Resolution establishing an Independent Redistricting Commission (IRC) to conduct public engagement and recommend a new City Council District election map based on 2020 U.S. Census data. To meet this mandate a random draw took place at a public meeting on Aug. 26, 2021 to select each member of the Commission. The 8-member Commission consisted of one member for each of the City's six districts, one (1) city wide commissioner, and one alternate Commissioner. Lapkoff & Gobalet Demographic Research, Inc. was hired to assist with their expertise and provided a plan drawing 'pieces tool' to the commission and public for use. The Commission held seven public hearings from August 2021 through February 2022.

The IRC created criteria for finalization of a final map including keeping percent deviation below 10% and keeping the map contiguous & compact. On Feb. 28, 2022 the IRC adopted Map 4A, a minimal change redistricting map and presented this map to the City Council at the March 22, 2022 meeting. Council voted unanimously to approve the introduction of an ordinance adopting a new City Council District map describing the district boundaries for the City of Santa Clara's By-District elections. Climate Action Plan Update

The Climate Action Plan (CAP) update will be presented at the Planning Commission and City Council Adoption Hearing. Following over two years of community engagement, the City developed a Draft Climate Action Plan to update the current CAP adopted in 2013. Adoption of the CAP Update would extend the City's Greenhouse Gas (GHG) emissions reduction goals through 2030, address new State requirements established since the 2013 CAP was adopted, and offer a Qualified CAP that would provide California Environmental Quality Act (CEQA) streamlining benefits. The Planning Commission Hearing is scheduled for **Wednesday, April 13**, and the City Council Hearing is scheduled for **Tuesday, June 7**. Bikeway Funding

On March 28, Mayor Lisa M. Gillmor, members of the Santa Clara City Council, and staff met with Congressman Ro Khanna to tour the City of Santa Clara's Bikeway Project. The Bikeway Project aims to install bike lanes, enhance safety, and reduce vehicle emissions along sections of De La Cruz Boulevard, Tasman Drive-Montague Expressway, and Scott Boulevard. Once completed, the projects will provide residents safe and valuable transit corridors to schools, libraries, and economic opportunities within Silicon Valley.

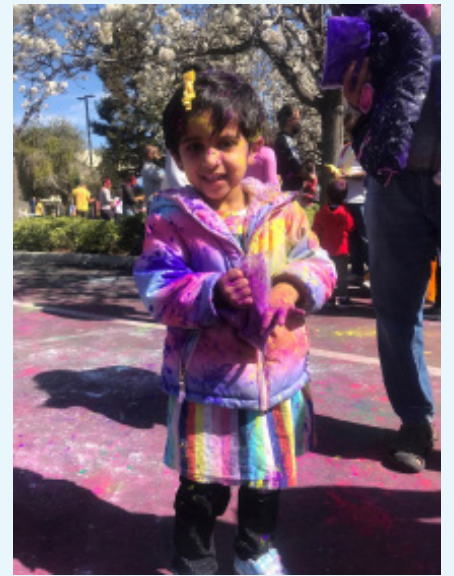

Pruneridge Avenue Complete Streets Plan

On March 8, the City Council held a study session regarding the Pruneridge Avenue Complete Streets Plan (Plan). The goal of the Plan is to study and identify potential bicycle and pedestrian improvements on a 2.2-mile segment of Pruneridge Avenue from Pomeroy Avenue to Winchester Boulevard. Staff presented the latest roadway concepts and results of traffic and parking analyses. Based on feedback received from City Council, staff is investigating opportunities to implement bicycle improvements and reduce traffic congestion. Apply to Be a Crossing Guard

Crossing Guards play a vital role in the community to help children safely cross the street on their way to and from school, however our well-trained colleagues are also present to:

- Discourage children from behaving in an unsafe manner near traffic, such as darting into the street without looking or crossing against a traffic signal;
- Encourage children to walk their bicycle or scooter in crosswalks;
- Use existing gaps in traffic to help students cross safely. When the natural traffic flow does not allow enough time for children to safely cross a street, a Crossing Guard may create gaps by stopping traffic temporarily;
- Alert motorists that pedestrians of unsafe traffic safety behaviors; and,
- Observe and report any incidents or conditions that present a potential safety hazard.

Crossing Guards generally work approximately 15 hours per week in an as-needed, non-benefitted capacity. Applicants must have a valid California driver's license and be at least 21 years of age. Earth Day and Arbor Day Celebration

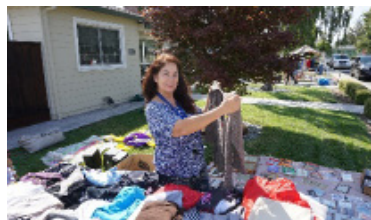

Household Hazardous Waste Drop-off

Santa Clara residents can safely dispose of household hazardous waste (HHW) at the free HHW drop-off event that will take place on **Saturday, April 30**.

Residents must register to attend this event by calling the County Household Hazardous Waste Program at 408-299-7300 or by visiting hhw.org. Hazardous items that can be disposed of include fluorescent light tubes, compact fluorescent lightbulbs, paint, automotive fluids, cleaners, solvents, batteries, propane and helium tanks, fertilizers, pesticides, wood preservatives, sharps containers, prescription medications, electronic waste (e-waste), and other types of household hazardous wastes. Items NOT accepted include large household appliances, ammunition, explosives, or containers larger than five gallons. Contact the Police Department at 408-615-4700 regarding the disposal of ammunition or explosives. Per County of Santa Clara event guidelines, face coverings are required for unvaccinated individuals that cannot maintain a six-foot distance from others.

Annual Cleanup Campaign

Santa Clara's Annual Cleanup Campaign will take place from **May 2 – May 27**. On designated weekends, **eligible** residences may set out bulky items that are not routinely collected by weekly solid waste services. Collection crews will pick up furniture, appliances, e-waste, tires, residential construction debris and yard waste. All concrete, asphalt, dirt, brick, rocks, drywall and/or sawdust **MUST** be set out in a construction debris bulk bag to prevent it from entering the storm drains. Acceptable bags are made of heavy-duty tarp or plastic material made specifically for construction debris and can be no larger than one cubic yard in size. Debris bulk bags can be purchased at a retailer of your choice or at the Municipal Utility Services counter located at 1500 Warburton Ave. for \$22.26 each starting April 4. Failure to use debris bags to contain residential construction/demolition debris is subject to a \$150 fine. A total of one cubic yard of bagged debris will be picked up at no charge. Any additional bagged material will be collected for a fee of \$25 per cubic yard. Household hazardous material is not accepted.
