Request:

General Plan Amendment, Planned Development (PD) Rezoning, Development Agreement, and Architectural Review of the 48.6-acre site to allow the development of up to approximately 4.9 million square feet of new development, including approximately 1.8 million square feet of residential uses (1,800 units), approximately 3 million square feet of office space, approximately 100,000 square feet of neighborhood retail, approximately 10,000 square feet of childcare facilities, and community spaces. Approval of the proposed General Plan Amendment and PD Rezoning Project will require actions by the City of Santa Clara, including

the preparation and certification of an Environmental Impact Report (EIR).

As the Lead Agency, the City of Santa Clara will prepare the EIR for the above-referenced Project. The City is seeking comments from Responsible Agencies and the public as to **the scope and content** of the environmental information that should be considered for inclusion in the EIR for the proposed project. The project description, location, and potential environmental effects are contained in the materials provided in the form of a Notice of Preparation (NOP).
