

State Requirements


- General Plan Required Elements: 7 (+ 1 or 2*)
- Housing Element must be reviewed / approved by California State Housing and Community Development (HCD)
- Jurisdictions must update their housing elements every eight (8) years:
 - Cycle 5 Housing Element certified 2/13/2015
 - Cycle 6 Housing Element due 1/31/2023





Components

- Review of previous Housing Element
- Goals, Programs, and Policies
- Housing Needs
- Governmental and Non-Governmental Constraints
- Sites Inventory and Analysis
 - Availability per State criteria
 - RHNA capacity per State criteria





Regional Housing Needs Allocation (RHNA)

- State Department of Housing and Community Development (HCD) determines regional housing needs by affordability levels for 8-year planning cycles
- Association of Bay Area Governments (ABAG) allocates share of region's housing needs by affordability level to every jurisdiction
- Local jurisdictions update their housing elements every 8 years to demonstrate available capacity to accommodate their allocation



Regional Housing Needs Allocation (RHNA)

- Housing Element must demonstrate capacity for full development of RHNA within the 8-year time period & provide annual progress reports
- RHNA Allocation is divided up by income level
 - Very Low Income (0-50% AMI)
 - Low Income (50-80% AMI)
 - Moderate Income (80-120% AMI)
 - Above Moderate / Market Rate (>120% AMI)





- Citywide Affordable Housing Requirements (adopted January 2018)
 - Projects of 10+ units provide at least 15% of units affordable at average income <= 100% AMI
 - Projects <10 units can pay In-Lieu Fee or provide 1 inclusionary unit
 - Option for alternative fulfillment that benefits the City
 - Commercial linkage fees






Neighboring Cities Affordable Housing, Citywide Rental

SUBJECT

Senior Advisory Commission Work Plan & Goals Update for FY2021/22

BACKGROUND

The Senior Advisory Commission developed potential priorities and interests of older adult residents of Santa Clara aged 50 and over, using the results from the 2017 Senior Needs Assessment and the eight (8) domains of the WHO Age-Friendly City program. The Age-Friendly Cities' domains include: Economics and Employment; Community; Housing; Outdoor Spaces and Buildings; Transportation and Streets; Health, Wellness, and Nutrition; and Social and Civic Engagement. On August 23, 2021, the Commission adopted their goals and work plan as follows:

1. Advocate for Affordable and Convenient Housing

- a. Provide two (2) presentations (January/May) and three (3) articles for the Senior Center Newsletter (October, February, May) updating older adults on current affordable housing projects in Santa Clara.
- b. Provide two (2) presentations (January/May) and three (3) articles for the Senior Center Newsletter (October, February, May) updating older adults on current rental assistance programs in Santa Clara.
- c. Send representative to attend Housing Commission meetings when they begin *(on hold)*.

2. Develop Opportunities to Promote Health, Wellness, and Nutrition

- a. Educate and provide resources for older adults transitioning through COVID-19 by offering two (2) presentations (December/April) on the topics of "Coping in a New Phase", and "The Affects to our Mental Health", and one (1) "share your experience" opportunity in March.
- b. Host the "Be Strong, Live Long" Health & Wellness Fair on Friday, May 20, 2022.
- c. Send representative to attend ADA Committee meetings (on hold).

DISCUSSION

Each sub-committee provides an update on the efforts and progress toward accomplishing the FY2021/22 Work Plan & Goals to the Commission for discussion. The sub-committees will verbally present their status reports as follows:

- 1. The Affordable and Convenient Housing sub-committee will report out on the Community Development Department May 23 presentation; Providing updates on current affordable & convenient housing projects for older adults, how Housing Elements benefits the older adult population, and projects in the near future that would benefit older adults;
- 2. The Affordable and Convenient Housing sub-committee for the Housing Commission is on hold until further notice;
- 3. The Health, Wellness, and Nutrition sub-committee will report out on any updates;
- 4. The Health, Wellness, and Nutrition committee will report out on any additional

SUBJECT

Senior Advisory Commission FY2022/23 Work Plan & Goals Discussion

BACKGROUND

At the beginning of each fiscal year, the Senior Advisory Commission develops a Work Plan and a set of activities to focus Commission discussion and effort throughout the year. The Plan is created by using the eight (8) domains of the World Health Organization's Age-Friendly City framework, reviewing the past Senior Needs Assessment, noting any significant changes and/or current trends relating to the senior population, and developing proposed policies or resources to meet Santa Clara's specific needs. The Commission suggests potential goals, evaluates resources available as well as Commissioner's interests at the June meeting, then prioritizes and finalizes the Work Plan at the July meeting of the new fiscal year.

DISCUSSION

Using the results from the 2017 Senior Needs Assessment and building upon the strategies that were suggested by focus group participants and partners, the Senior Advisory Commission will consider the priorities and interests of older adult residents of Santa Clara ages 50 and over, and brainstorm potential goals utilizing the eight (8) domains of the Age-Friendly City framework:

- A. Economics and Employment,
- B. Community,
- C. Housing,
- D. Outdoor Spaces and Buildings,
- E. Transportation and Streets,
- F. Health, Wellness, and Nutrition,
- G. Social and Civic Engagement, and
- H. Access to Community Resources and Information.

At the July 25, 2022 Senior Advisory Commission meeting, the Commission will discuss which goals will be prioritized and various activities suggested in support of the goals based upon available resources. Subcommittees of less than a quorum may also be assigned based upon commissioner's particular interests and capacity. Then the FY2022/23 Work Plan will be discussed and finalized.
