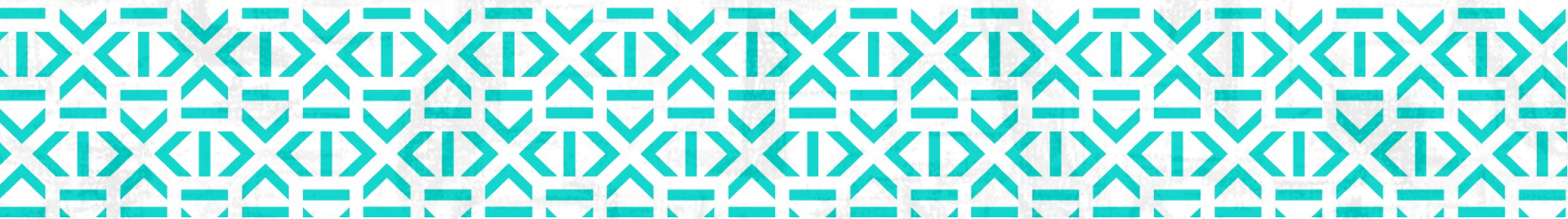
Point in Time Count Update

- Overall Point in Time Count numbers for the County of Santa Clara were released on May 16th
 - Full report, with breakdown by city jurisdiction, is expected in July

2019 & 2022 Point in Time Count for Santa Clara County

<i>Unsheltered</i>	7,922	7,708
<i>Sheltered</i>	1,784	2,320
Overall Point in Time Count:	9,706	10,028

Outreach Services



What We Can Expect From Outreach

It Will:

- Help build trust needed to connect people with services
- Address unmet basic or health-related needs
- Complement other services in the system of care

It Might:

- Serve as an access point into Coordinated Entry System to connect individuals with housing
- Prevent deaths or other crises
- Get an individual sheltered

It Won't:

- Prevent people from being unhoused in the first place
- Increase the supply of supportive or affordable housing
- End homelessness

Outreach Outcomes

Street Outreach Enrollments Jan 2019-Dec 2021	Living Situation at Exit
Not Collected	201 (54%)
Shelter/Institution	89 (24%)
Permanent Housing	41 (11%)
Unsheltered	27 (7%)
Deceased	2
Still Engaged (no exit)	14 (4%)
Total	374

- Data include all households with a connection to the City of Santa Clara
 - Client address
 - In which city do you spend most of your time?
 - Which city did you live in prior to becoming homeless?
 - If employed, what city do you work in?
 - If you go to school, in which city is your school?
 - Zip Code of Last Address
