SUBJECT

Informational Update on Senior Center Memberships

COUNCIL PILLAR

Deliver and Enhance High-Quality Efficient Services and Infrastructure

BACKGROUND

According to a 2021 Cost of Services study performed by ClearSource Financial Consulting, the Parks & Recreation Department receives an 89% subsidy from the General Fund. The fees charged for programs and services supplement the General Fund subsidy by approximately 11%. The Cost of Service study is used to identify and calculate the City's full cost for providing a specific program or service which are included in the City's Municipal Fee Schedule and reviewed and adopted by Council annually.

The City's budget has a structural deficit, which means that the City's cost to provide programs and services continues to exceed the City's anticipated revenue. Staffing, programs and hours of service have already been reduced to balance the budget. In addition, revenues generated from program fees will be used to offset program expenses.

On June 21, 2021, the Council directed staff to bring forward a Parks & Recreation Cost Recovery Policy as part of the Fiscal Year 2022/23 budget review process. The policy development was informed by a community input survey and a special meeting of the Parks & Recreation Commission, Senior Advisory Commission, and members of the Youth Commission in spring of 2022. The policy is a foundational and widely used tool that aligns cost recovery and program pricing with the levels (%) of benefit received by the individual and/or community. In principle, the more the community benefits, the greater their cost recovery share will be.

Following public input and Council review on April 5, 2022, the Cost Recovery Policy guidelines were adopted on April 19, 2022. Resident Senior Center use is placed in the 1-20% cost recovery category. Direct costs for Senior Center operations is approximately \$1.6 million/year (not including nutrition, health & wellness, maintenance, or facility repair/renewal). Direct costs to run the drop-in programs is approximately \$579,000/year, including lap swim. Membership fees are expected to generate about 2% - 7% cost recovery which is on the lower end of the cost recovery range for this type of program/service.

DISCUSSION

In April 2022, Council reviewed and adopted a Parks & Recreation Cost Recovery Policy. It provides a framework for understanding the cost of services, the level of individual or community benefit, how much program participants might pay and how much City subsidy would be expected. To implement the Cost Recover Policy, the Parks & Recreation Department created two (2) membership levels for participation at the Senior Center: (a) Basic, and (b) Premium. These memberships include access to programs and facilities. Patrons may choose their membership level based on interest; and, for those who may need financial assistance, a partial grant is available. Membership Fees and the General Fund subsidy support the facilities, programs, and services offered.

Beginning October 3, Memberships will be renewed at the new levels when a patron's membership expires (ex. if your membership expires in January you will need to renew and pay the fee at that time). Scholarships will be made available for those who qualify. Current Senior Cards benefits are valid through the expiration date. Memberships are available at two benefit levels:

Senior Center

The Senior Center aims to be a safe, positive, and welcoming environment for all who visit, offering programs and services geared towards the adult community, ages 50 and up, at various abilities and life stages. The Senior Center offers a combination of Drop-in Programs, Senior Nutrition Program, Health & Wellness Program, Workshops and Trainings, a Fitness Center, Fitness Classes, Natatorium, Woodshop, Lapidary, Ceramics, and Special Interest Classes. The Senior Center is a community benefit for persons ages 50 + and is committed to providing low-cost programs that maintain or increase health & wellness, help reduce isolation, and provide residents access to resources.

New Memberships

In April 2022, Council reviewed and adopted a Parks & Recreation Cost Recovery

Policy. It provides a framework for understanding the cost of services, the level of individual or community benefit, how much program participants might pay and how much City subsidy would be expected. The policy helps inform the City budget and program pricing decisions since the City faces both immediate and longer-term fiscal challenges where program expenses surpass City income. To implement the Cost Recover Policy, the Parks & Recreation Department has created two (2) membership levels for participation at the Senior Center: (a) Basic, and (b) Premium. These memberships include access to programs and facilities. Patrons may choose their membership level based on interest; and, for those who may need financial assistance, a partial grant is available. Membership Fees and the General Fund subsidy support the facilities, programs, and services offered.

Senior Center Memberships

Memberships will be renewed at the new levels when a patron's membership expires (ex. if your membership expires in January you will need to renew and pay the fee at that time). Scholarships will be made available for those who qualify. Current Senior Card benefits are valid through expiration date.

Frequently Asked Questions

Do I need a membership to utilize the Senior Nutrition Program at the Senior Center?

- No. Access to Nutrition does not require a membership.
- The Senior Nutrition Program is a Santa Clara County supported program. Persons 60+ are eligible to have lunch at the Senior Center for a small donation.

Do I need a membership to visit with a nurse at the Senior Center?

 No. Access to the Health & Wellness Program does not require a membership. Case Management and public health nursing services at the Senior Center are accessible without a membership.

What if I want to buy something from the Snack Bar and sit with my friends in the lobby and visit? Do I need a membership?

 No. Senior Center Membership is not required to enter or sit in the Lobby or Snack Bar area.

Do I need a Membership to take a class at the Senior Center?

 No. Individuals can register for classes without a membership.

When do I need to update my Senior Center Membership?

Memberships are good for one year, from date of purchase. Individuals will need to renew at the front desk when the membership expires (ex. If you enrolled for a Senior Card in December 2021, you would need to purchase a membership in December of 2022.

Where can I use my Senior Center Basic or Premium Membership?

- Senior Center Basic
 Membership is valid at the Santa Clara Senior Center.
- Premium Membership is valid at the Senior Center AND at the International Swim Center and other City aquatic facilities (see City website for specific updates, schedules, and changes).

SUBJECT

Senior Advisory Commission Work Plan & Goals for FY2022/23

BACKGROUND

Using the results from the 2017 Senior Needs Assessment and taking into consideration the eight (8) domains of the Age-Friendly City guidelines. Age-Friendly City domains include: Economics and Employment; Community; Housing; Outdoor Spaces and Buildings; Transportation and Streets; Health, Wellness, and Nutrition; Social and Civic Engagement; and Access to Community Resources and Information. The Senior Advisory Commission prioritized the interests and needs of older adult residents of Santa Clara ages 50 and over given limitations of available City resources, and finalized the goals and work plan at the August 22, 2022 meeting and adopted as follows:

- 1. Advocate for Affordable and Convenient Housing Commissioners Hubbard & Freitas.
 - a. Appoint representative(s) to attend the Housing Commission meeting.
 - b. Research the Housing page of the City's website.
 - i. Disseminate information to the older adult population via two (2) presentations at the Senior Center (November and April) and provide one article for the Senior Center newsletter (February).
- 2. Encourage and Promote the use of Outdoor Spaces and Buildings Commissioners Freitas & Sterling.
 - a. Participate in public design phase discussions of new park facilities and spaces, including park improvement projects. Monitor the Parks & Recreation Commission for outdoor spaces in development that may enhance outdoor recreation for older adults.
 - b. Provide organized activities at the Senior Center
 - i. Billiard tournament (February)
 - ii.Bean Bag Toss (April)
- 3. Advocate for Affordable, Convenient, and Safe Transportation and Streets
 - a. Monitor public conversations regarding City of Santa Clara's transportation needs and the Council's proposed solutions. *Commissioners Hubbard & Toledo.*
 - i. Monitor and report monthly to Commission regarding planning phases of the VIA Shuttle
 - b. Review and provide feedback to the Pedestrian and Bicycle Master Plans for potential access improvements, and provisions for general safety and develop strategies to address excessive speeding on bike paths. Commissioners Drozek, Hohenshelt & Freitas.
 - i. Send representative(s) to attend Bicycle & Pedestrian Advisory Committee meeting.
- **4. Develop Opportunities to Promote Health, Wellness, and Nutrition** *-Commissioners Hohenshelt & Hubbard.*
 - a. Provide resources to the community on the topic of Alzheimer's and Dementia, including programming to reduce isolation.

i. Host an Alzheimer's and Dementia presentation at the Senior Center in March.

5. Provide Access to Community Resources and Information

- Appoint representative(s) to attend the ADA Committee Meetings. Commissioner Hubbard.
- b. Host the "Be Strong, Live Long" Health & Wellness Fair. Commissioners McCauley, Toledo, & Hubbard.

 - ii.Go over Commission assignments for the event (March)
 - iii. Schedule Commission assignments for the event (April)
 - iv. Deliver Good Neighbor letter to the neighborhood (May)
