SUBJECT

Youth Commission FY2022/23 Work Plan & Goals

BACKGROUND

The Youth Commission develops an annual work plan through discussions of current trends and civic needs relating to the youth and teen population. Over the past few terms, the Commission has chosen various goals including:

- To encourage health and wellness;
- To provide public outreach and education; and
- To foster inclusiveness in the community.

DISCUSSION

At the November 8, 2022 meeting, the Youth Commission finalized its work plan priorities and goals for the FY2022/23 term. The work plan priorities include:

- Community Building: intergenerational conversations with seniors, highlighting various cultures, and hosting a Sunset Cinema movie on May 12;
- Youth Outreach: Hosting TED-type talk, creating new youth resident resources, and public outreach;
- Youth Empowerment: Opportunity to highlight youth voices via audio podcast, newsletter, etc.

Commissioners have formed committees for each priority to develop specific plans of action. Committee members will provide updates on their progress during the Youth Commission's monthly meetings throughout the term.

The final work plan goals for this term will continue to be discussed, evaluated, prioritized, and implemented in the context of existing City resources and any remaining pandemic related public health guidelines.

ENVIRONMENTAL REVIEW
