# The Brown Act

- State law, passed by the State Legislature in 1953
- Incorporated into the State Constitution in 2004
- Intended to:
  - Provide openness and transparency
  - Ensure that the public has meaningful access to its agencies
  - Provide the public with the means to provide their input



- Core tenet of the Brown Act:  
“All ***meetings*** of the ***legislative body*** of a ***local agency*** shall be ***open and public***, and all persons shall be permitted to attend any meeting of the legislative body of a local agency, except as otherwise provided in this chapter.” Gov’t. Code § 54953(a)
- Is Santa Clara a “local agency?” YES
- Is the Civil Service Commission a “legislative body?” YES



- What constitutes a meeting? (GC § 54952.2)
  - A majority of the Commission to be present
  - The Commissioners must be in the same location at the same time (teleconference included)
  - The purpose is “to hear, discuss, deliberate, or take action on any item”
  - The item being discussed or decided is within the subject matter jurisdiction of the legislative body



- Exceptions to the definition of “meeting”
  - Attending a conference
  - Attending a community meeting
  - Attending an open/noticed meeting of another local agency legislative body
  - Attending a social/ceremonial event
- DO NOT discuss Commission business
- Also, communications of less than a majority



- What is a “serial” meeting?
  - A series of communications of any kind (including any type of electronic means), either directly or through intermediaries, to discuss/deliberate/decide an issue within your jurisdiction
  - Daisy Chain (A to B, then B to C, then C to D, etc.)
  - Hub and Spoke (A to B, then C, then D, or intermediary contacts A, then B, then C, etc.)
  - Most common error: EMAIL (no “Reply All”)



- Teleconferencing – new laws
  - Traditional pre-pandemic teleconferencing
    - Notice and posting
  - *\*NEW\** Just cause and emergency circumstances exceptions to notice and posting requirements (effective currently)





- AB 922 – Social media constraints
  - Went into effect January 1, 2021
  - No “discussions” on social media
    - Cannot respond in any way (including posting comment or using the “like” button) to a post by another commissioner relating to something within the subject matter jurisdiction of the CSC



- How can we make meetings “open and public?”
  - First, we provide notice via published agendas
  - Second, public can provide their input
    - Public comment allowed both generally ("Public Presentations" heading on the agenda) and specifically as to each item on the agenda
  - Third, no non-agendized discussions



- **Open vs. Closed Session**
  - Default is that everything is on open session
  - Certain issues may be discussed in closed session – employee discipline (deliberation) and the litigation exception
  - Confidentiality
- **Penalties/Enforcement**



# Robert's Rules of Order

- City Code § 2.10.020 requires that City Council meetings be conducted pursuant to Robert's Rules of Order and Boards & Commissions follow this requirement as well
- The purpose of such rules is to promote orderly conduct, clarity, and protect the rights of the minority by facilitating discussion



- Establish Quorum with Roll Call
  - Quorum = minimum number to make decision (3)
    - 50% +1 of the entire membership of the body (3)
    - If only a quorum is present, the meeting may continue, but all motions must be unanimous to pass
    - Charter Section 1003, “The affirmative or negative vote of a majority of the entire membership of such board or commission shall be necessary for it to take action. ”



- Format for each agenda item:
  1. Chair reads the agenda item description
  2. Chair asks for staff report/presentation
  3. Commissioners can ask questions of staff
  4. Chair invites public comment on the item
  5. Chair invites a motion and second
  6. Chair asks Commissioners to discuss motion
  7. Vote is taken



# Public Records Act

- Followed the Brown Act, same policy intent
- Enacted in 1968, modeled on FOIA
- Was incorporated into the Cal Const.
- Basic tenet: Public records shall be disclosed to the public, upon request, unless there is a legal basis not to do so (exemptions)
- As a legislative body of the City, the work of the CSC is subject to the PRA



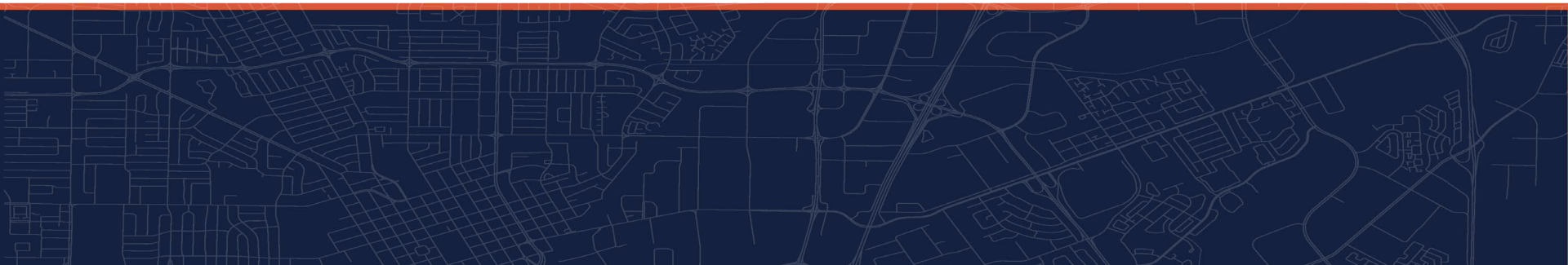
- What is a public record?  
The PRA defines “public records” as “***any writing*** containing information relating to the ***conduct of the public’s business prepared, owned, used, or retained*** by any state or local agency regardless of physical form or characteristics.”
- Record retention requirements
- Penalties/Enforcement

# Why Are We Here?

- Allegation of Employee Misconduct
- Civil Service Rules & Regs
  - § 6.4: Causes for employee discipline
  - § 6.6: Notice of discipline
  - § 7.3: Right to appeal to Board of Review (BOR)



# What is a BOR Hearing?



- Arguments from each party
- Usu. represented by counsel
  - Dif. attys for dept. & BOR
- Opening & closing arguments
- Both sides present evidence & call witnesses
- BOR adjourns to deliberate & render opinion



# Rules & Procedures for BOR Hearings

Approved by Civil Service Commission 8/11/03  
Revision Approved 9/15/03

## CITY OF SANTA CLARA

### Rules and Procedures for the Conduct of Hearings and Boards of Review

#### PREAMBLE:

- A. The Civil Service Commission shall meet and act as a Board of Review when required under the provisions of Section 7 of the Civil Service Rules and Regulations.
- B. The purpose of these Rules and Procedures is to provide a fair and impartial hearing in which the facts are developed in an expeditious manner.
- C. To guide the Board in its conduct involving a termination, suspension, demotion or reduction in pay as defined therein, the following rules and procedures shall be adhered to:
  1. The hearing shall be: informal, open to the public, unless otherwise ordered by the Board or at the request of the person involved.



## ***Before the hearing...***

- Employee notified in writing
- Employee has 10 days to appeal
- CSC sets date(s) for the hearing
- Parties submit witness lists & written statements
- Employee may request that hearing be closed to the public





# ***At the hearing...***

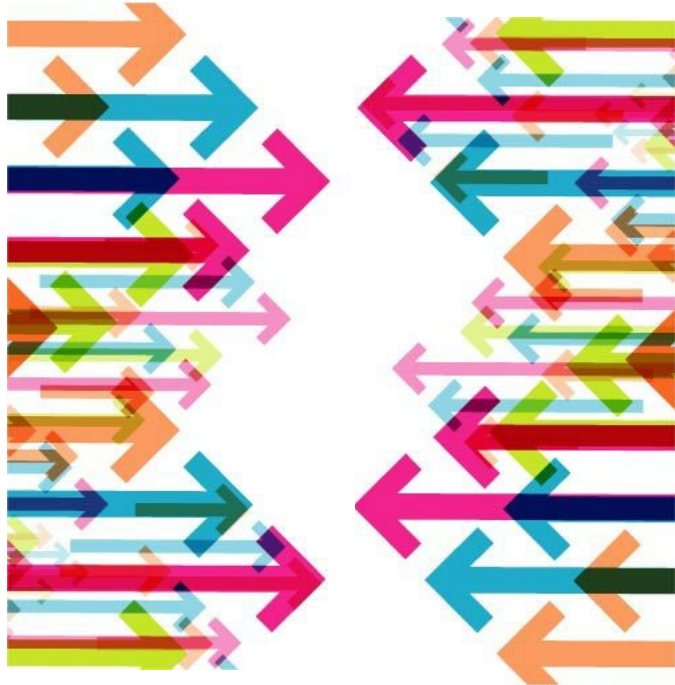
- Procedural discussion
- Opening statements
- Present testimony (in person or by affidavit)
- Introduce exhibits
- Cross-examine witnesses
- Closing statements







# Order of Proof



- Dept present evidence supporting the discipline
- Employee presents evidence in defense
- Parties may cross-examine witnesses after direct testimony
- Dept provides rebuttal
- Employee provides rebuttal



# Conduct of the Hearing

- Make no assumptions about appropriateness of disciplinary action
- Be guided by the weight of the evidence presented; receive no evidence outside the hearing
- Ask additional questions of witnesses to understand the pertinent facts
- Must be disinterested, impartial arbiter
- Assist the Chair to ensure a fair & orderly hearing



# Conduct of the Hearing

- Chair serves as presiding officer.
  - Opens & closes the hearing
  - Explains hearing procedures
  - Administers oaths





# Conduct of the Hearing

- Chair serves as presiding officer.
  - Rules on *objections*



- Irrelevant
- Repetitious
- Already established
- Confusing

– Accepts evidence into the record<sup>11</sup>



# ***After the hearing...***

- Board adjourns into closed session
- Board renders decision within 10 days
- Decision must be in writing
- Uphold, overturn, or *modify* department decision
- Decision is binding on the employee and the department





# How do you Reach a Decision?



- Majority vote (3 / 5)
- Standard of Review is *de novo*
- *Burden of proof* is on the Department
- Make your decision on a *preponderance* of the evidence
- Ok to consider any prior disciplinary action

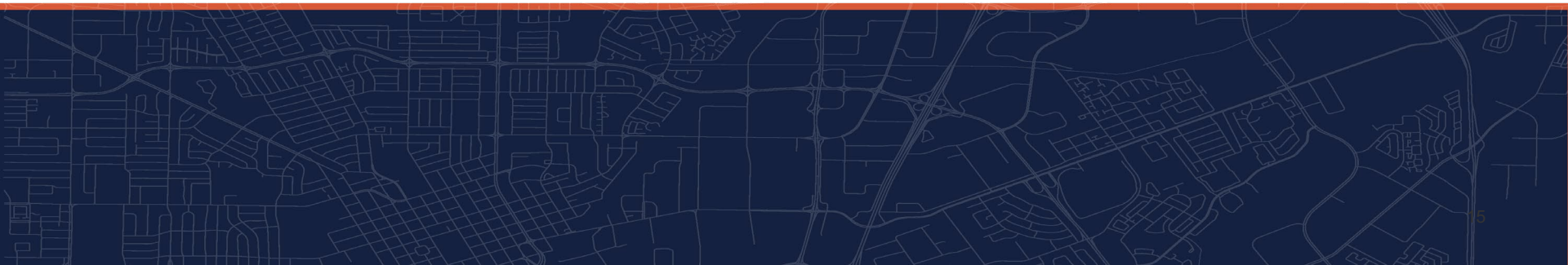

#### ACTION AND AUTHORITY

Eligible lists generally shall remain in force for a period of one year (if not extended) for non-sworn positions, pursuant to Civil Service Rules, Sec. 4.3. The Water & Sewer Utilities Department is requesting to abolish the Associate Engineer (Civil) (Job Code 321) eligible list based on the authority of Civil Service Rules, Sec. 4.8, "Eligible lists may be abolished by the Director of Human Resources under the following conditions: a) If the list contains fewer than five (5) names." If the eligible list contains more than five names, and the list is proposed to be established, the action is brought to the Civil Service Commission for approval.

Under direct supervision, the Associate Engineer (Civil) performs field and office work in design, construction and/or maintenance programs; provides technical assistance in the implementation of plans and programs; and may work with the public and consultants on various projects providing guidance and information. This is a journey-level professional engineer classification expected to perform the full range of professional engineering duties. Incumbents may exercise direct supervision over professional and paraprofessional engineering staff.

#### DISCUSSION

The Associate Engineer (Civil) (Job Code 321) classification is used in the Department of Public Works and the Water & Sewer Utilities Department. The Water & Sewer Utilities Department conducted a recruitment in March 2023 to fill a single vacancy. An eligible list comprised of five (5) candidates was created in June 2023.

Since the establishment of the eligible list, all candidates on the list have been invited to a department second-round interview, and all candidates participated. From among these candidates, one (1) candidate was given a conditional offer and accepted. Upon receipt of the City's formal offer, however, the candidate declined the offer, but requested to remain on the eligible list for future vacancies. The remaining candidates on the eligible list did not possess the desirable qualifications for the vacant position. The eligible list is currently set to expire on June 7, 2024.

Abolishing the eligible list would allow Human Resources to conduct another recruitment and create a new eligible list for Associate Engineer (Civil) (Job Code 321).

#### ACTION AND AUTHORITY

The Water & Sewer Utilities Department is requesting to extend the probationary period for an employee based on the authority of the Civil Service Rule 4.20(b), "Regular classified employees may have their probationary period extended by the Commission for reasons of sickness or absence."

#### DISCUSSION

A Water & Sewer Maintenance Worker I (Employee No. 07959), was hired on December 12, 2022. This position is subject to a 12-month probationary period that was originally scheduled to end on December 11, 2023. However, the employee was placed on modified duty from April 17, 2023 through July 27, 2023, which interrupted the continuous 12-month probationary period cycle. Due to their placement on modified duty, the Department has not had adequate time to assess the entirety of the employee's performance of the full duties of a Water & Sewer Maintenance Worker I. The employee missed an entire rotation assignment which is critical to the assessment of their performance on the job. Therefore, the Department is requesting an extension of the probationary period by approximately fifteen (15) weeks or equivalent to the amount of time the employee is placed on modified duty in their current classification.

The original end date of the employee's probationary period is December 11, 2023; the new probation end date is proposed to be March 25, 2024. If the employee is placed back on modified duty, the Human Resources Department may extend the probationary period to reflect the additional time placed on modified duty. This will allow for a complete 12-month probationary period during which the employee is on full duty to conduct the proper assessments required during probationary status.

#### ENVIRONMENTAL REVIEW
