Re: Coordination of 2025 and 2026 Work in City Streets
City of Santa Clara Pavement Preservation Ordinance

To Whom It May Concern:

On February 19, 2019, the City Council of the City of Santa Clara adopted Ordinance No. 1998 that places a restriction on the excavation of recently treated pavements for a specific period of time following the pavement treatment. This restriction is 3 years for streets that have been resealed, and 5 years for streets that have been resurfaced, reconstructed, or constructed.

The City of Santa Clara Department of Public Works is responsible for administering the provisions of the Ordinance, planning and performing street pavement maintenance work, and administering the City's Encroachment Permit Program for persons seeking to make excavations in City streets.

The Department's planned 2025 pavement maintenance work was first made available in June 2023 for coordination with work by planned by potential excavators. If excavators plan to perform work on those streets contained on the 2025 tentative street maintenance list, they are encouraged to perform the work **prior to April 1, 2025**.

The Department's planned 2026 pavement maintenance work is now made available for coordination with work by planned by potential excavators. If excavators plan to perform work on those streets contained on the 2026 tentative street maintenance list, they are encouraged to perform the work **prior to April 1, 2026**.

Upon completion of the pavement maintenance work, the restrictions on excavations will be enforced.

Please note that the Department is enforcing restrictions on streets which have received pavement treatments since 2020, including streets currently under construction in 2024. Please reference the webpage listed above for information on the restricted streets.
