TRANSIENT OCCUPANCY TAX, COMMUNITY FACILITIES DISTRICT TAX, AND TOURISM IMPROVEMENT DISTRICT ASSESSMENT REFUND CLAIM FORM

The Santa Clara City Code (SCCC) Chapter 3.25, Transient Occupancy Tax, Section 3.25.150 states whenever the amount of any tax, interest, or penalty has been overpaid, paid more than once, or erroneously or illegally collected or received by the City, it may be refunded by the Director of Finance, provided a claim in writing therefor is filed with the Director of Finance within three years of the date of payment, stating, under penalty of perjury, the specific grounds upon which the claim is founded. The claims shall be on forms furnished by the Director of Finance.

Businesses subject to the Tourism Improvement District assessment may request a refund of paid assessments by completing this form and providing supporting documents and proof of payment.
